Fiscal Year Ended June 30, 1973, alluding to the circumstances presently under consideration, Mayor Doorley's role in the promotion of this facility and hopes the present situation is speedily resolved.

COUNCILMAN LYNCH requests and is granted the Privilege of the Floor stating that for Himself and COUNCILMAN JOHNSON, as Members of the Providence Civic Center Authority, that they are concerned with the circumstances and since the subject matter is under investigation it should not be discussed at this time.

ADJOURNMENT

There being no further business, on motion of COUNCILMAN LYNCH, seconded by COUNCILMAN DARIGAN, The City Council adjourns at 9:25 o'clock P.M. (EDT), to meet again on THURSDAY, NOVEMBER 1, 1973, at 8:00 P.M. (EST).
