AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1984-53 APPROVED JULY 20, 1984, BY TRANSFERRING THE SUM OF EIGHT THOUSAND DOLLARS (\$8,000.00) FROM DEPARTMENT OF PARKS - DEVELOPMENT AND ENVIRONMENT, ITEM 0 TO DEPARTMENT OF PUBLIC PROPERTY - PURCHASING, ITEM 0.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1984-53 of the Ordinances of the City of Providence, as approved July 20, 1984, entitled: "An Ordinance Making an Appropriation of One Hundred Seventy-One Million Fifty-Six Thousand One Hundred Seventy-Seven Dollars and Fifty-Seven Cents (\$171,056,177.57) for the fiscal year ending June 30, 1985, as amended, is hereby further amended by transferring the sum of Eight Thousand Dollars (\$8,000.00) from Department of Parks - Development and Environment, Item 0 to Department of Public Property - Purchasing, Item 0.

SECTION 2. This Ordinance shall take effect upon its passage.

Dear Carolyn,

This is in response to the Finance Committee's inquiry regarding funding for the proposed Clerk I position in the purchasing division of the Department of Public Property.

I am advised by Mark Dunham, assistant to the Finance Director, that sufficient funds exist in the Parks Department "C and D" account to fund the Clerk I position. A number of positions in that department are funded but have been vacant for some time, and because only about \$8,000 is necessary to fund the Clerk I position through the remainder of the fiscal year, Parks has saved enough money already to fund the Clerk I position.

I spoke to Parks Superintendent Merrick Cook about this matter today, and he agreed to this proposal.

Therefore, the only thing that remains to be done is to transfer the necessary money from Parks to Public Property. Could you ask the City Clerk to draft the necessary ordinance?
