



Dear Sir:

As the result of your letter, and a communication from the City Council, a survey was made to determine the need of a crossing guard at the intersection of Huntington and Calhoun Avenues. It was revealed that the number of children crossing this intersection ranged from 14 to 20; and there is traffic control present at this location in the form of a "Boulevard Stop" sign.

In an effort to cover all locations that justify such supervision, the present complement of personnel has been allocated to render as much protection as possible and still maintain adequate police protection. At present, supervision to assist the children attending the Assumption School in crossing highways has been established at Huntington Avenue and Dexter St., Waverly St. and Cranston St., and Potters Avenue and its intersections of Dexter St., Homestead St. and Cranston St..

Under the circumstances, it is not advisable to assign a crossing guard at this location, because to do so would involve removing someone from a present assignment, which would do more harm than good. Our program is to make assignments which serve the majority of the children, and at present, any reassignment would be detrimental to that plan.

In view of these facts, I am sure that you will realize our situation and agree that your request can not be met.
