


Dear Honorable Members:

The Committee on Finance met on October 26, 1995 at which time they were to take up the Residency Issue of Mr. Charles Garganese, Jr., Public Administrator who is in violation of Section 1210 of the Providence Home Rule Charter of 1980.

Mr. Garganese was invited to attend the meeting, but chose to communicate with the City Council via letter indicating the fact that he has not sold his home as of this date. Mr. Garganese stated that if he is not domiciled here in the City of Providence by the end of the year, he will resign effective January 1, 1996. But, the Committee on a vote of its members present, voted to instruct the Personnel Director to notify Mr. Garganese that as of November 3, 1995 he is no longer employed by the City of Providence in his capacity as Public Administrator.
