## ORDINANCES SECOND READING

The following Ordinances were in City Council February 15, 1973, Read and Passed the First Time and are Returned for Passage the Second Time:

An Ordinance Amending Chapter 16, Section 13 of the Code of Ordinances of the City of Providence Relative to Obstruction of Public Ways of Travel and Residential Picketing.

*Be it ordained by the City of Providence:*

Section 1. Section 16-13 of the Code of Ordinances of the City of Providence is hereby amended to read as follows:

“(a) No person shall stand on any footwalk, sidewalk, parking lot, doorstep or in any doorway in this City as to obstruct a free passage for foot passengers; or to hinder or delay, passers-by or persons residing or doing business in the vicinity thereof.”

“(b) Any person obstructing any footwalk, sidewalk, parking lot, step or doorway shall move

immediately when requested to do so by a police officer.”

Section 2. “Residential Picketing.”

“1. Declaration. It is hereby declared that the protection and preservation of the home is the keystone of democratic government; that the public health and welfare and the good order of the community require that members of the community enjoy in their homes and dwellings a feeling of well-being, tranquility, and privacy, and when absent from their homes and dwellings, carry with them the sense of security inherent in the assurance that they may return to the enjoyment of their homes and dwellings; that the practice of picketing before or about residences and dwellings causes emotional disturbance and distress to the occupants; obstructs and interferes with the free use of public side-

walks and public ways of travel; that such practice has as its object the harassing of such occupants; and without resort to such practice full opportunity exists, and under the terms and provisions of this ordinance will continue to exist for the exercise of freedom of speech and all other constitutional rights; and that the provisions hereinafter enacted are necessary for the public interest to avoid the detrimental results herein setforth."

"2. It shall be unlawful for any person to engage in picketing before or about the residence or dwelling of any individual."

Section 3. This Ordinance shall take effect upon its passage.

An Ordinance Authorizing the Board of Park Commissioners to Cause All City Owned Parks, as it May Deem Necessary, to be Closed to the Public from the Hours of 9:00 O'Clock P.M. to 7:00 O'Clock A.M.

*Be it ordained by the City of Providence:*

Section 1. The Board of Park Commissioners is hereby authorized to cause all City owned parks, as it may deem necessary, to be closed to the public from the hours of 9:00 O'Clock P.M. to 7:00 O'Clock A.M., and post notices accordingly.

Section 2. This Ordinance shall take effect upon its passage and any Ordinance; or rule or regulation of the said Board, inconsistent herewith, is hereby repealed.

*Now, Therefore, Be It Resolved*, In acknowledging his inspirational leadership and the civic pride he has shown on behalf of those youngsters in organized Little League baseball, it is hereby declared that a certain Little League field located upon Dexter Training Ground is hereby designated as "Edward B. Zanfagna Little League Field," and

*Be It Further Resolved*, That the said field be officially dedicated as such on Sunday, May 6, 1973.

*Whereas*, Mr. Ionata, a graduate of Brown University, Class of 1926, earned his Bachelor of Science Degree, Majoring in Mechanical Engineering, and was elected to the Sigma Xi Honorary Scientific Society, and

*Whereas*, Following his college education, he was affiliated with the Providence Gas Company for a period of thirty-eight years, and

*Whereas*, In 1947, Mr. Ionata was appointed as one of the original members of the Advisory Board to the Air Pollution Engineer of the City of Providence, served for a decade, and then was appointed as a Member of the Building Board of Review, a capacity in which he is presently serving, and

*Whereas*, Mr. Ionata gave much of his time to the Federal Hill House, and was elected for three consecutive terms as its President, and for twelve successive terms as a Member of the Board of Directors, and

*Whereas*, Mr. Ionata was elected President of the Italo-American Club of Rhode Island, the oldest organization of Americans of Italian Extraction in the State of Rhode Island.

*Now, Therefore, Be It Resolved*, In Noting the accolade given to Domenico A. Ionata, as Engineer of the Year, His Honor Mayor Joseph A. Doorley, Jr., and the Members of the City Council do hereby congratulate the Society in

its selection and express their respective best wishes for his continued good health, and

*Be It Further Resolved*, That the City Clerk is hereby directed to cause a duly engrossed copy of this Resolution to be transmitted to Mr. Ionata.

**COUNCILMAN XAVIER (By Request):**

Resolution Requesting the Commissioner of Public Utilities of the State of Rhode Island to Cause More Frequent Preventive Maintenance to be Made of New England Telephones Installed Outdoors for Public Convenience.

*Whereas*, Complaints have been made, with respect to outside telephone facilities owned by the New England Telephone, to the effect that the same are often inoperative, particularly along rural public highways, and

*Whereas*, One public carrier driver recently reported that four such telephones could not be utilized as they were in a state of disrepair and that the coins deposited were not returned since the caller was unable to communicate, at that point, with the telephone operator, and

*Whereas*, An inquiry of the preventive maintenance scheduled by the New England Telephone Company reveals that outside telephones are checked by company collectors over a period of from 70 to 126 days, and sometimes in between said number of days, by New England Telephone salesmen,

*Now, Therefore, Be It Resolved*, That the Commissioner of Public Utilities is requested to cause the New England Telephone to remedy

this maintenance practice and to further request that more frequent preventive maintenance be instituted, as above stated, and that the public convenience be better serviced, as was the intent when the privilege of such outside telephone installations was granted to the said New England Telephone.

### COMMITTEE ON PUBLIC WELFARE

Resolution Requesting the School Committee to Continue to Maintain Almy Street Elementary School, as a Special Facility School for Handicapped Children.

*Whereas*, The Providence School Committee proposed to transfer handicapped students presently attending classes at Almy Street Elementary School to Kenyon Street Elementary School, and

*Whereas*, It appears that the proposed handicap facilities at Kenyon Street Elementary School will not be completed as scheduled, since certain office space at Kenyon Street will be converted to classroom space after September of 1973; and, accordingly, would not be as adequate as at Almy Street Elementary School at present,

*Now, Therefore, Be It Resolved*, That the Providence School Committee is requested to con-

tinue and maintain the present facilities for handicapped students at Almy Street Elementary School at least through June of 1974.

Resolution Relative to Financial Support for Non-Food Service Equipment for Breakfast and School Lunch Programs.

*Whereas*, There is statutory authority in the State of Rhode Island, making it mandatory for all schools to participate in the program that needy children, from deprived homes, be served adequate breakfasts and school lunches, and

*Whereas*, This program, which requires equipment at the various schools, is in need of funding for such equipment, since it poses a tremendous

hardship on small religious Day Schools as well as other public schools.

*Now, Therefore, Be It Resolved,* That the President of the United States is urgently requested to cause financial support, by way of the related Federal Agency to fund the program, for Non-Food Service Equipment for serving of breakfasts and school lunches in the schools of the City of Providence, so as to adequately feed children who do not benefit from such necessary meals at home.

Resolution Authorizing the City Solicitor to Appear before the 1973 Session of the General Assembly and Urge Passage of an Act Relative to Corliss Park.

*Resolved,* That the City Solicitor be and hereby is authorized to appear before the 1973 Session of the General Assembly and urge passage of an Act Relative to transferring and conveying Corliss Park to the City of Providence, substantially in accordance with the accompanying draft act. (For draft of Act, See Files of City Council.)

Resolution Requesting the Providence School Department to Cause New Sewing Machines be Placed in Nathan Bishop Junior High School and Other Public Schools.

*Resolved,* That the Providence School Department is requested to cause new and properly maintained sewing machines to be placed in Nathan Bishop Junior High School, and in all other Public Schools in the City of Providence, and that said machines be adequate in number.

Resolution Authorizing the Committee on Public Welfare to Grant Permission for All Future Night Sports Events Proposing to Use the Neutaconkanut Park Complex.
