
The enclosed resolution was passed by the Woonsocket City Council at its meeting held January 21, 1997.





RESOLUTION IN SUPPORT OF AMENDING RHODE ISLAND GENERAL LAW 16-21-8

WHEREAS, Rhode Island General Law 16-21-8 mandates that school systems employ nurse teacher personnel certified by the Department of Elementary and Secondary Education for the administration of school health programs; and

WHEREAS, the statutory mandate creates a shortage of personnel due to the necessity of dual professional certifications.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WOONSOCKET, RHODE ISLAND AS FOLLOWS:

SECTION 1. That the City Council of the City of Woonsocket strongly urges the Legislature to amend RIGL 16-21-8 to delete the requirement of teacher certification in said statute and require only a certified nurse for said position.

SECTION 2. That a copy of this resolution be forwarded to the Governor, area Legislators, and the Councils of the several cities and towns.

SECTION 3. This Resolution shall take effect immediately upon its passage by the City Council.
