Gentlemen:

Upon receipt of a petition from the City Council which requested elimination of the NO PARKING regulation on Weeden Street from Atwells Avenue to Federal Street, the traffic engineer would like to report the following findings:

Weeden Street from Atwells Avenue to Federal Street is only 13 feet wide. If one vehicle is parked at the curb it barely leaves space enough for another vehicle to pass. This would be particularly hazardous if the passing vehicle were large such as a truck or possibly a fire engine.

Up until October, 1951, NO PARKING has been established on one side of Weeden Street only. Traffic conditions were bad enough at that time to warrant the establishment of NO PARKING on both sides of this street. As far as traffic is concerned, we feel that the existing regulations are justified and should remain in force and therefore recommend that this petition be denied.
