No. 104 AN ORDINANCE AMENDING SECTION 165.2 OF CHAPTER 2 OF THE 1946 REVISED ORDINANCES, ENTITLED, "ADMINISTRATION", AS AMENDED, BY ADDING A CERTAIN HOLIDAY, RELATIVE TO MEMBERS OF THE FIRE DEPARTMENT.

Approved February 21, 1964

Be it ordained by the City of Providence:

Section 1. Section 165.2 of Article XV of Chapter 2 of the 1946 Revised Ordinances, entitled "Administration" as amended, is hereby further amended to read as follows:

Sec. 165.2 HOLIDAY PAY FOR POLICEMEN AND FIREMEN

Policemen and firemen, whether on duty or not, shall be entitled to and shall receive one extra days pay for the following holidays; said pay to be computed on a basis of one-fifth of a full week's pay, viz.:

New Year's Day
Independence Day
Labor Day
Columbus Day
Armistice Day
Thanksgiving Day
Christmas Day

In addition thereto firemen shall be entitled to Memorial Day on the same terms and conditions as hereinbefore set forth.

Sec. 2. This ordinance shall take effect upon its passage.

NOW THEREFORE BE IT RESOLVED, That if upon such inspection it is so determined that violations do in fact exist, then proceed to bring appropriate legal action against such owner to correct the violations and/or to raze this apparent fire hazard, health menace and eye sore in this otherwise well maintained neighborhood, and




