AN ACT

AUTHORIZING THE DIVISION OF PARKS AND RECREATION OF THE STATE OF RHODE ISLAND TO TRANSFER TO THE CITY OF PROVIDENCE A PARCEL OF LAND IN SAID CITY FOR SCHOOL AND RECREATION PURPOSES.

It is enacted by the General Assembly as follows:

SECTION 1. The Division of Parks and Recreation of the State of Rhode Island is hereby authorized to transfer or convey by suitable deeds to the City of Providence, a tract of State-owned land adjacent to the Esch Hopkins Junior High School in the City of Providence for school and recreation purposes, being Lot 13, on Assessor's Plat 76, in the office of the Tax Assessor of the City of Providence, as said plat stands January 19, 1956, the area containing approximately 261,443 square feet of land, used at the present time by the City of Providence, with the permission of the State of Rhode Island, for school and recreation purposes, and shown as a cross section adjacent to the Esch Hopkins Junior High School in Providence, on a map entitled "Providence, R. I., P. W. Dept., Engineering Office, City Property Section, Plat No. 061265, date October 6, 1955."

SEC. 2. This Act shall take effect upon its passage, and all acts, or parts of acts, inconsistent herewith are hereby repealed.
