AUTHORIZING DEED TO  
BROWN UNIVERSITY OF  
PART OF FONES ALLEY.

KNOW ALL MEN BY THESE PRESENTS,

THAT the CITY OF PROVIDENCE, a municipal corporation existing under the laws of the State of Rhode Island in consideration of the sum of ONE DOLLAR (\$1.00) to it paid by BROWN UNIVERSITY IN PROVIDENCE IN THE STATE OF RHODE ISLAND, AND PROVIDENCE PLANTATIONS, an educational corporation existing under the laws of said State, and located in said City of Providence, hereinafter sometimes called the "grantee", the receipt whereof is hereby acknowledged, does hereby remise, release and forever quitclaim unto the said grantee, its successors and assigns forever, but without covenants, express or implied,

That certain parcel of land situated in said Providence, constituting the portion of Ponca Alley lately abandoned by said City for highway purposes by Resolution No. 261 Approved May 6, 1960, bounded and described as follows:

Beginning at the intersection of the easterly line of Brown Street with the northerly line of Ponca Alley, as formerly existing, thence easterly along the northerly line of Ponca Alley, as formerly existing, One Hundred Fifty (150) feet to a corner, thence southerly Twenty (20) feet, more or less, to a point in the southerly line of Ponca Alley, as formerly existing, One Hundred Fifty (150) feet easterly from the easterly line of Brown Street for a corner, thence westerly along said southerly line of Ponca Alley, as formerly existing, One Hundred Fifty (150) feet to the easterly line of Brown Street, thence northerly along the easterly line of Brown Street Twenty (20) feet, more or less, to the northerly line of Ponca Alley, as formerly existing, and the point or place of beginning.

Said parcel is shown as shaded area and designated by the letters A - B - C - D on that plan accompanying said abandonment resolution and entitled "Providence, R.I. P.W. Dept. - Engineering Office, City Property Section, Plan No. 052003, Date March 7, 1960".

TO HAVE AND TO HOLD the same, with all rights, privileges and appurtenances therunto appertaining, unto and to the use of the said grantee and its successors and assigns forever.

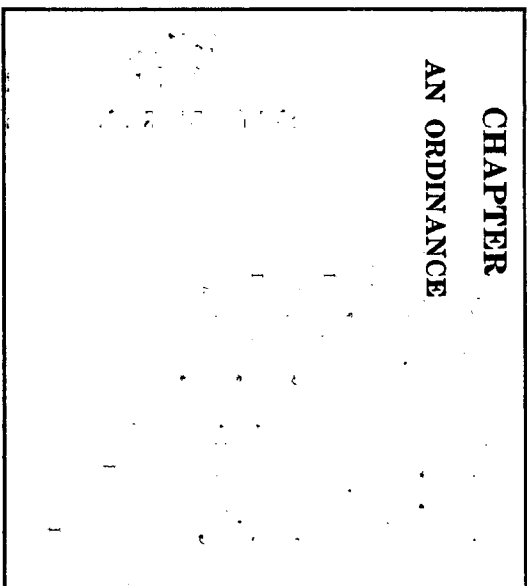
