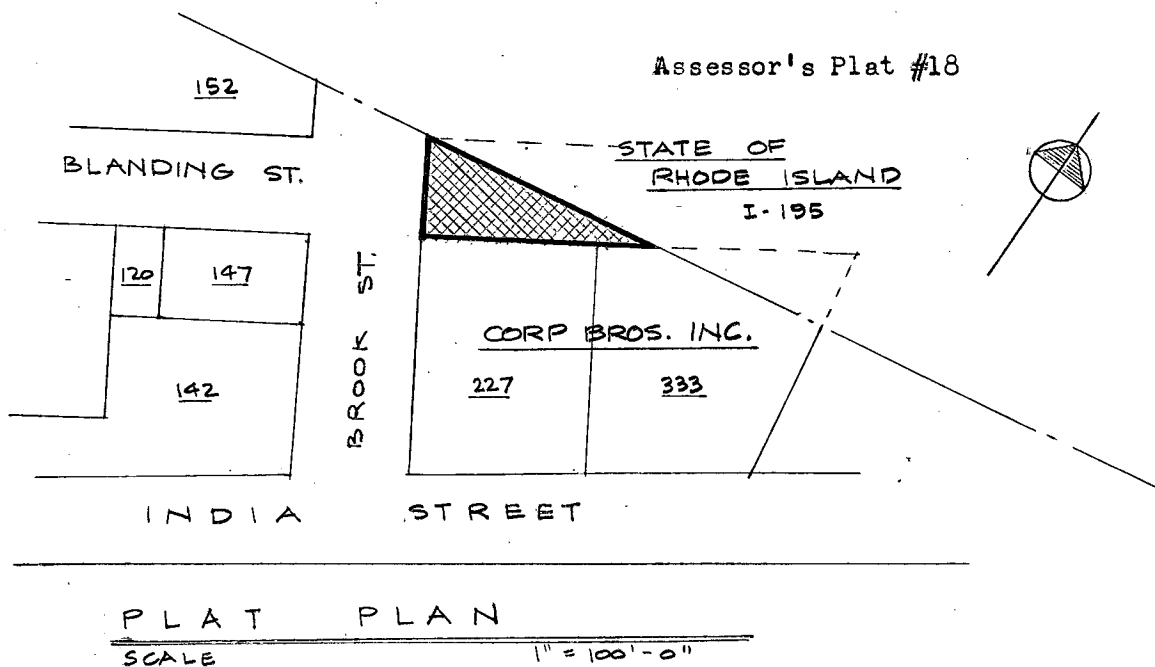

This referral is a request to abandon a portion of Blanding Street.


On an inspection and photographic survey it was determined that the area was paved, but in need of repair. The surrounding area is generally industrial and in fair to poor condition.

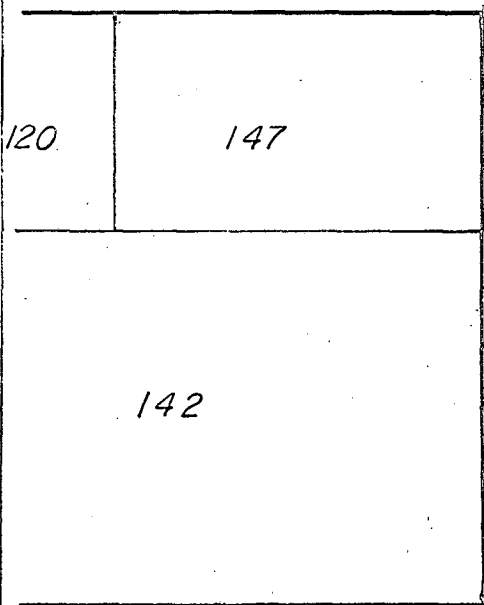

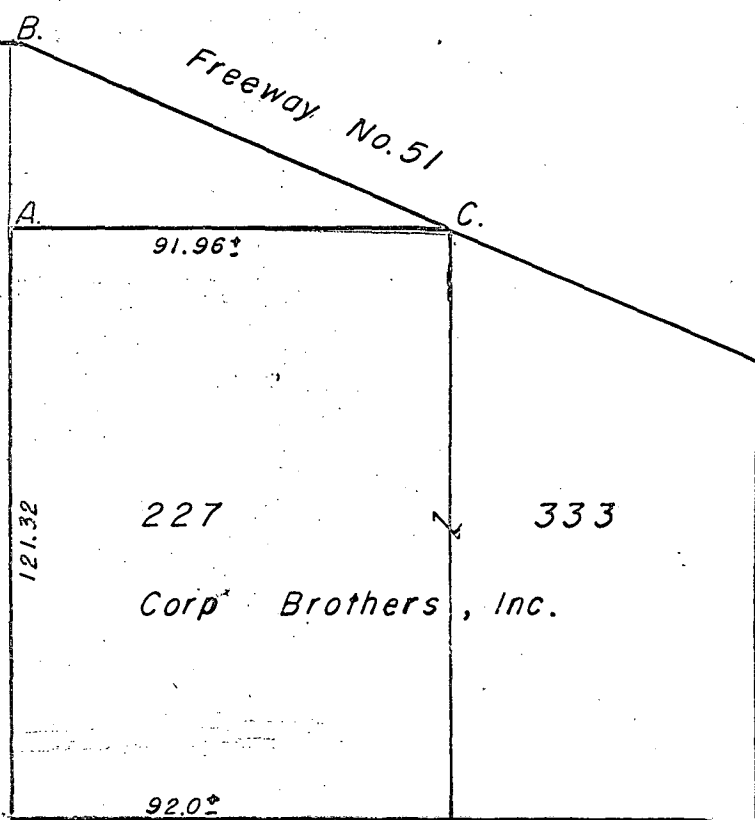

Dear Councilman Payne:

On March 21 we received an official memorandum from the Department of the City Clerk regarding a petition under consideration by your Committee to abandon a portion of South Street from the westerly line of Hospital Street to the range of the easterly line of Imperial Place. We have reviewed our distribution plans and we have a 6" cast iron main in this section of South Street being considered for abandonment. It has a depreciated value in the amount of \$1,358.87. There is a 4" general service that supplies water to Coro which will no longer receive water as a result of this abandonment and if they desire an additional service, they will have to make application and pay the department the regular service connection charge from some other street.

We respectfully request your Committee to withhold final action on this matter until the petitioner pays for the depreciated value of that section of the main in South Street that will be abandoned. We plan to file a bill with the City Collector's Office covering the amount set forth above.



The shaded area indicates that portion of South Street (the area between Imperial Place and Hospital Streets) that the Coro Company seeks to have abandoned. Such abandonment would allow Coro to connect its present properties with its newly acquired properties. 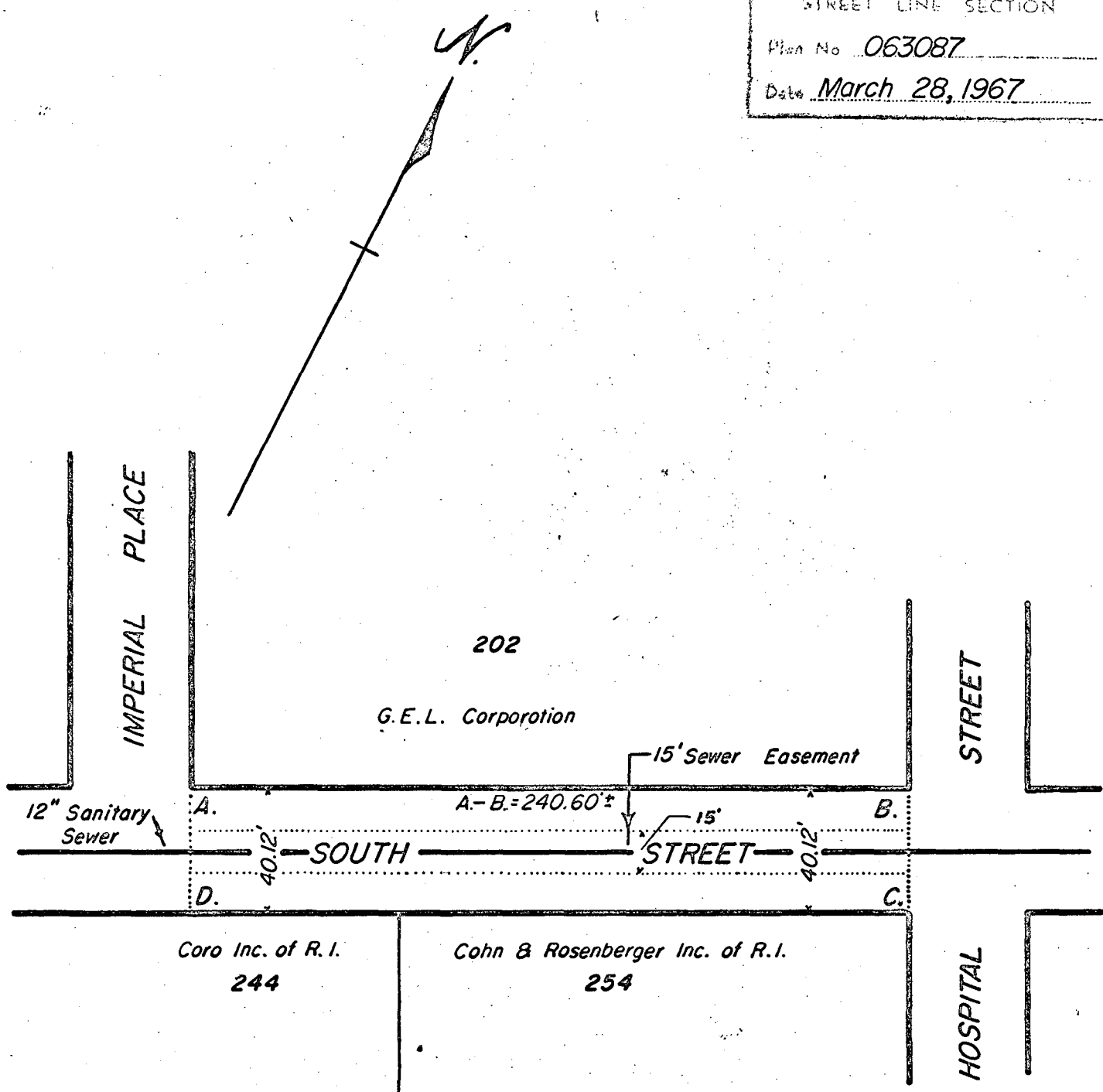

Street from the westerly line of
Hospital Street, westerly to the
range of the easterly line of Im-
perial Place, shall be a shaded
area and designated by the let-
ters A-B-C-D-A on the accom-
panying plan entitled, "Providence,
R.I., P. W. Dept.—Engineering
Office, Street Line Section, Plan
No. 063087, Date March 28,
1967," has ceased to be useful to
the public and the same is aban-
doned as a public highway and the
damage to the abutters is ap-
praised at nothing and so award-
ed, and it is further stipulated that
the abandoned portion of South
Street be subject to a perpetual
right and easement, fifteen (15)
feet in width to be granted to the
City of Providence, and any and
all persons, who may acquire own-
ership of the above described area
by virtue of the aforesaid pro-
posed abandonment for the pur-
pose of maintaining, operating or
rebuilding a sewer within, across,
through and upon the above de-
scribed premises together with the
right of the City of Providence by
its agents, servants, officers and
employees, to enter said premises
at all reasonable times for the
purpose of repairing, rebuilding and
operating a sewer with such tools
and other equipment as may be
necessary and provided further
that it is expressly understood and
agreed that no structure shall be
placed over or upon said ease-
ment or the land over or upon said
easement be used so as to endan-
ger the sewer in anyway, and it is
further

ORDERED, That the Director of
Public Works, be and he is hereby
directed to cause a sign to be
placed on that certain portion of
South Street from the westerly line
of Hospital Street, westerly to the
range of the easterly line of Im-
perial Place, abandoned as afore-
said, having thereon the words:
"Not a Public Highway," and it
is further ORDERED, That after
the entry of this order or decree
the City Clerk shall cause a notice
thereof to be published in a news-
paper published in the County of
Providence, at least once each
week for three successive weeks
and a further and personal notice
shall be served by the City Ser-
geant upon every owner of land
abutting that certain portion of
South Street from the westerly
line of Hospital Street, westerly
to the range of the easterly line
of Imperial Place, which has been
abandoned, who is known to re-
side within this state.


On an inspection and photographic survey it was determined that one house was being erected on one of the lots. The surrounding area is in very good condition.

MINUTE

"Reverend Richard M. Dudley was born March 31, 1888 in Beaufort, South Carolina, son of the late Samuel and Millie (Watkins) Dudley. He moved to Providence, Rhode Island in 1906, and became a member of the Congdon Street Baptist Church where he served for fifty years. He served in many areas of leadership such as church treasurer, church school teacher, President of the Men's Club, Chairman, the Board of Deacons. In 1958 he was licensed to preach the Gospel of Christ.

For many years Mr. Dudley was active in Republican politics and community affairs of the East Side. He was past president of the East Side Neighborhood Council and the East Side Republican Club. In 1956 he was unsuccessful Republican candidate for City Council from Ward 3.

A dynamic voice in the quest for civil rights, he testified on behalf of fair housing legislation, and fought to prevent demolition of homes on Lippitt Hill for urban redevelopment. He was a member of the NAACP. He served as interim minister of St. James Baptist Church, Woonsocket, R. I., and later joined that church, where he continued to serve as assistant minister and community leader."




