Memorandum to Mayor Reynolds:

Reference-Resolution at City Council Meeting Thursday, Sept. 7th, 8 P.M. requested by Mr. Wexler relative to Shelter Survey to be conducted through the joint efforts of the Dept. of Bldg. Inspection, Civilian Defense and Supt. of Health.

The following information is presented to assure the completion of the above request.

The Dept. of Defense approved the amount of \$208,000,000 Oct. 12, 1961 to be used in making a complete survey of shelter facilities thru out the country. The study will be divided into three phases.

PHASE I

This survey has as an objective, the inventory of population, and potential public fallout shelters by census tract. Also to collect data for subsequent machine computation of potential factors.

Its task will be to analyze available data, from maps, records and reports and complete a computing record card indicating protection factor of 20 or better and potential shelter space for 50 or more people.

With the assistance of local authorities they will obtain entrance to buildings, make estimates, collect day and night population data by census tract etc.

A complete print-out of the result of their survey will be furnished to the Navy Bureau of Docks & Yards as a basis of PHASE II work.

A copy of base maps and list of names and addresses of the facilities will be furnished to local officials. These local officials will contact owners for formal right of entry during PHASE II. Local officials will prepare plans for use of shelters.



PHASE II

(a) For shelters designated by D.O.D.

To determine feasibility of increasing shielding to provide minimum protection factor, improving habitability to meet minimum requirements and increasing snelter capacity.

(b) Make preliminary cost estimates for necessary modifications.

(c) Mark acceptable snelters after agreements have been signed by owners of properties.

Criteria relative to capacity, net space per person, headroom, storage space, ventilation, power and water and sanitary facilities have been developed.

Permits for entering, inspecting, marking and stocking snelter areas for public use will be obtained by local C.D. officials.

Phase I & II of the operation will require assistance from the Director of the Department of Building Inspection, the Director of Civilian Defense and the Superintendent of Health.

It is expected that their work will be completed by Sept. 1962.

PHASE III which will require additional funds from the Federal Government will involve hardening of snelter facilities and stocking foodstuff, supplies and equipment adequate for 14 day occupancy by number of people indicated.

The target date for completion of the last phase is Dec. 1962 and it is estimated that shelter capability developed in existing buildings will provide adequate fallout protection to 25% of our present population. This is a tremendous effort directed toward National Survival. However, since its anticipated effectiveness is expected to provide for only one quarter of our citizens it indicates the absolute necessity for the individual family type fallout shelter which we are urging every family to prepare for their occupancy if disaster strikes.



I feel certain that the Bureau of Yards and Docks, U.S.N. that has been delegated by the Corps of Engineers as the supervising agency to conduct this most important survey will enjoy the full cooperation of all municipal departments.

Gentlemen:

The Providence Redevelopment Agency, in accordance with the provisions of paragraph 12 of Chapter 1375, as amended, of the Ordinances of the City of Providence, approved December 2, 1960; and Title 45, Chapter 32, Section 5 of the General Laws of Rhode Island, 1956; hereby reports concerning the proposed sale of real property within the Mashapaug Pond Redevelopment Project.

Glass-Tite Industries, Inc., the prospective purchaser, manufacturer of hermetic seals, semi-conductors, and electronic components, proposes to erect a building of 86,000 square feet for manufacturing purposes. Indications are such that the present employment figure of approximately 550 will be increased by an initial 200-300 and that employment should potentially reach over 1000.

The Agency proposes to convey to Glass-Tite Industries, Inc., a Rhode Island corporation, a parcel of 295,515 square feet at .22 cents per square foot for a sale price of \$65,013.30.

QUARTERLY REPORT OF THE QUALITY OF MILK SOLD IN PROVIDENCE BY RETAIL DISTRIBUTORS

The following table gives the results of the average of analyses made by this department during the third quarter of the year 1961:

No distributor's name is listed under a particular grade of milk unless at least four samples of that grade were analyzed during the quarter. The standard plate count of colonies of bacteria is obtained by using the logarithmic average set forth in the United States Public Health Service Milk Code.

CERTIFIED MILK

The legal standards for Certified Milk are those adopted by the American Association of Medical Milk Commissions, Inc. and in effect at the time of production.

Unless otherwise indicated on the label it shall contain an average of 4.0% of butter fat with a minimum of 3.5% for individual samples and a minimum of 12% of total solids.

The average bacterial count of Pasteurized Certified Milk shall not exceed 500 colonies of bacteria per cubic centimeter.

GRADE A MILK—PASTEURIZED

Grade A Pasteurized milk is produced on farms scoring not less than 85% using the dairy score card of the U. S. Department of Agriculture. The butter fat shall average not less than 3.50% for any four samples taken in a period of not less than 30 days or more than 90 days. The bacteria count shall have a logarithmic average of not greater than 10,000 for any 4 consecutive samples.

The Milk Solids Not Fat shall average 8.50%.

The average bacteria count of pasteurized milk at the time of delivery to the consumer shall not exceed 25,000 per cubic centimeter and the average per centum of butter fat shall be not less than 3.25 per centum by weight.

The Milk Solids Not Fat shall average 8.25%.

PASTEURIZED SELECTED MILK

Under state law only three grades of milk are recognized, Certified, Grade "A", and Regular. Milk may also be classified as homogenized, skim, or defatted. Buttermilk and Cultured Buttermilk are other recognized types defined by state law. Goat milk is also defined. All milk sold in the City of Providence is required to be pasteurized.

While there is no separate legal classification of Pasteurized Selected Milk, some dealers utilize this "grade" as a price differential. Check this grade with dealer's Grade "A" or Regular.



REMARKS

During the quarter 1,164 different samples of milk were analyzed. 145 were below chemical standard of fats and/or solids and 59 showed excess coliform or other bacteria.

During the same period, 145 samples of cream showed 9 samples below in fats and/or solids and 31 above limits in bacteria.


