## CHAPTER 1977-51

No. 796 **AN ORDINANCE** AMENDING THE APPROPRIATION  
ORDINANCE CHAPTER 1977-35, APPROVED JULY 18, 1977 BY  
APPROPRIATING A SUM NOT TO EXCEED FIFTY THOUSAND  
(\$50,000.00) DOLLARS FOR THE CITY OF PROVIDENCE'S  
FOOD STAMP PROGRAM.

Approved December 23, 1977

**Be it ordained by the City of Providence:**

SECTION 1. Chapter 1977-35 of the Ordinances of the City of Providence, as approved July 18, 1977 and entitled: "An Ordinance Making Appropriation of \$108,255,372.79 For The Support of the City Government for the Fiscal Year Ending June 30, 1978, as amended" is hereby further amended by appropriating the sum of Fifty Thousand (\$50,000.00) Dollars for the City of Providence Food Stamp Program. Said sum to be transferred to the Revolving Fund and any unspent monies shall revert back to the General Fund.

SECTION 2. The said sum of Fifty Thousand (\$50,000.00) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and the City Treasurer to transfer a like sum from funds not otherwise appropriated.

SECTION 3. This Ordinance shall take effect upon its passage.

I am preparing an amended Appropriation Ordinance in the amount of \$50,000.00 for the City share of operating the Food Stamp Program of the City of Providence.

This is being done now, because of the lack of information available at budget time. For example, there was a claim pending against the City from the State for the Food Stamp theft of a couple of years ago. The claim was processed by myself and finally cleared up.

Secondly, the constant possibility of future thefts at these stamp centers were eliminated July 1, 1977 when I had both centers in the projects closed and the sale of stamps were shifted over to the banks.

The third problem concerned the receipt of funds from the State for which nothing was being paid over to the City until the Insurance claims and the City payments to the banks were resolved.

This being resolved, makes it necessary to appropriate an additional \$50,000.00 Dollars in the 1977-1978 budget year. This budget item was included in prior years.
