





This petition from the Committee on Public Works proposes the abandonment of that section of Benefit St. located from Tockwotton St. in a generally northwestern direction to the border of State land adjacent to Route 195.

Inspection revealed that the land in question is dead end and roughly 100' deep. It is presently being used for parking.

Since this portion of Benefit St. is no longer of any use as a public highway, no objection is offered by this department to the proposed abandonment.



Relocation of Post Hydrant	862.50
Total	<u>\$1,749.98</u>

We are filing a bill with the City Collector's Office in the amount of one thousand seven hundred forty-nine dollars and ninety eight cents (\$1,749.98) and respectfully request that your committee take no action on this matter until the Water Supply Board is assured of payment for the items listed above. This sum does not include the relocation of the two services that are off the existing main.
