PRESENTATION OF RESOLUTIONS

COUNCILMAN GLAVIN and COUNCILMAN FARMER:

Resolution declaring the Office of Mayor vacant in accordance with Section 206(a) (5) of the Providence Home Rule Charter of 1980.

COUNCILMAN GLAVIN moves to amend the Resolution as follows: Line 1 following Sec. 206(a), delete the figure "(5)" and insert in lieu the figure "(4)".

This motion is seconded by COUNCILMAN DILLON.

The motion to Amend is Sustained.

Resolved, That in accordance with Sec. 206 (a) (4) of the Providence Home Rule Charter of 1980, the Office of Mayor of the City of Providence is hereby declared vacant.

COUNCILMAN GLAVIN moves that the Resolution be Read and Passed as Amended.

This motion being seconded by COUNCILMAN DILLON is Put to Vote and Passed by a Voice Vote.

The motion for Passage, as Amended is Sustained.

Resolution calling a Special Election for the Office of Mayor pursuant to Section 206(b) of the Providence Home Rule Charter of 1980.

Whereas, A vacancy exists in the Office of Mayor of the City of Providence, Rhode Island pursuant to Section 206(a) (5) of the Providence Home Rule Charter of 1980, caused by the final conviction of a felony or a crime of moral turpitude and exhaustion of all appeals from said conviction on April 23, 1984, of Vincent A. Cianci, Jr., and

Whereas, The said vacancy did occur more than One Hundred Eighty Days before the time of the holding of the next succeeding regular City Election, and

Whereas, In accordance with the provisions of Section 206(b) of the Home Rule Charter of the City of Providence, Rhode Island, it is mandatory that a Special Election for the purpose of filling such vacancy be held within ninety days of the

date of the occurrence of such vacancy, and

Whereas, Section 17-15-4 of the General Laws of the State of Rhode Island provides a primary election for the nomination of such city or town officials shall be held and the local board shall fix the date thereof; provided, however, that said primary election shall have been held by the thirtieth (30th) day preceding the date fixed for said election,

Now, Therefore, Be It Resolved, By the City Council of the City of Providence, Rhode Island, that, in compliance with the provisions of Section 206(b) of the Providence Home Rule Charter of 1980, the said City Council does hereby order a Special Election to be held on July 17, 1984, for the purpose of filling the vacancy in the Office of Mayor of the City of Providence, Rhode Island, caused by the final conviction of a felony on April 23, 1984 of Vincent A. Cianci, Jr., and

Be It Further Resolved, That the Board of Canvassers and Registration of the City of Providence, Rhode Island, and all other officers whose duty it is to prepare for elections, are hereby requested and notified to make such preparations for said election as required by law, and

Be It Further Resolved, That the City Clerk is directed to cause a certified copy of this Resolution to be transmitted to the Board of Canvassers and Registration of the City of Providence, Rhode Island; and that a duly certified copy of this Resolution be transmitted to the State of Rhode Island Board of Elections and to the Secretary of State of Rhode Island.

Read and Passed, on motion of COUNCILMAN GLAVIN, seconded by COUNCILMAN DILLON.

OATH OF OFFICE OF MAYOR

The Oath of Office is duly administered to
COUNCIL PRESIDENT JOSEPH R. PAOLINO,
JR., as Mayor of the City of Providence by
Honorable Anthony B. Sciarretta, Judge of
Probate Court of the City of Providence.

ADDRESS BY HIS HONOR THE MAYOR

Tonight is a new beginning for all of us — a
night for healing, and a fresh start.

By operation of law, I am charged with the
orderly administration of the affairs of the City
for the next 90 days. A decent man does not revel
in the misfortune of another, but neither does a
responsible man shirk a duty thrust upon him by
law. I am accepting the awesome obligation
placed upon me tonight.

I pledge to you that I will devote all of my
energy, all of my resources, to the task at hand. I
am here tonight to tell you that the past is behind
us, tomorrow and for all of the tomorrows that

follow, we must form "A New Pact for
Providence" — a solemn agreement that together,
using the greatest resources of this City — her
people — we will build a secure future for all of
our children and our children's children.

We must restore the confidence and trust of the
people of Providence in their government. We
must streamline our City's management
practices, route out corruption wherever it exists,
and establish an atmosphere of predictability,
stability and uncompromising professionalism.

Political differences have no place in this pact,
and we must set them aside now. Fear of change

has no place in this pact. Change is inevitable if progress is to follow. We must implement new and proven ideas and practices.

To progress, we must heal the wound that divided us, we must soften the rhetoric and strengthen our resolve to manage the City effectively, honestly and fairly.

As I look at you, the Members of the City Council — people with whom I have served for more than five years — I feel a strong sense of kinship and warmth. We have shared many of the City's triumphs and tribulations, and I think we are all keenly aware of Providence's uniqueness, of its resiliency and its vast potential. The tasks before us require the contributions of all the City's neighborhoods, ethnic groups, and civic leaders.

I pledge to run the kind of open, fair and honest administration that will encourage each of these vital segments of our City to roll up their sleeves and work together for the City's advancement.

Because the challenges before us are so urgent and demanding, I am taking the following immediate steps to assure the people of Providence that their City Government will be run efficiently and effectively:

Executive Order #1 Instituting Purchasing Controls

Executive Order #2 Instituting Personnel Controls

Executive Order #3 To Determine the Current Financial Status

In addition, I am also issuing an Executive Order creating a "Mayor's Management Task Force". This Task Force will assist and advise me on a daily basis to insure that the daily operations of the City are conducted in a business like manner.

One of the Task Force's prime objectives will be to protect Providence taxpayers from waste and mismanagement, while also protecting city employees from abuse or intimidation.

Tonight, I ask you all to enter with me into this pact for Providence.

We have a lot of work ahead of us, but with the prayers and support of all the people of Providence, the job of moving our City forward, will be accomplished. Together we will succeed.
