Dear Mayor Doorley:

Back in 1870 when the City of Providence was constructing its first water supply at Pettaconsett, it was necessary to run a 42" main from Pettaconsett to the former Sockanosset Reservoir. The land was acquired from Joseph S. Budlong and is recorded in the Cranston land records in Deed Book 51, page 444.

On April 8, 1959, we received a letter from the Real Estate Title Company of Providence which was in connection with a title they were clearing on property adjacent to our pipeline. I am enclosing a copy of the letter which shows the following provision of our deed:

"Also I hereby grant to the said City of Providence, its successors and assigns, the right to take earth from the adjoining land belonging to me, for the purpose of forming an embankment on said strip and of repairing and widening the same and of taking gravel from other land belonging to me for use in hardening the same."

Under Council Resolution No. 492 approved September 4, 1959 entitled "Resolution Authorizing the Mayor to Execute a Release Agreement with Herman F. Burlingame and wife Rose I. Burlingame and Atlantic Realty Company Relative to Land Held for Water Supply Purposes". These rights were released in Lots No. 35 and No. 42 referred to in the letter from the Title Company. The agreement was recorded in the Office of the City Clerk at Cranston, R. I. on October 15, 1959.

We now have a request for a release of these rights from Mr. Christopher Lombardi who owns Lot 680 and on his land they have constructed a restaurant. In fact, all the land referred to in the deed is completely built up with homes as the embankment of the pipeline was completed at the time the line was installed and there is no need for obtaining further material as provided in the Budlong deed.




