ORDINANCES SECOND READING

The following Ordinances were in City Council November 2, 1995, Read and Passed, the First Time, as amended and are severally returned for Passage the Second Time, as amended:

An Ordinance to amend Article VII, Section 21-141 — 21-149 of the Code of Ordinances of the City of Providence regarding Providence Review Commission, as amended.

Be it Ordained by the City of Providence:

Section 1. That Article VII, Sections 21-141 through 21-149 of the Code of Ordinances entitled "Providence Review Commission" is hereby repealed.

Section 2. That Article VII, Sections 21-141 through 21-147 of the Code of Ordinances shall read as follows:

Sec. 21-141. Declaration of Policy.

The city council finds that it is in the interest of the residents of the City of Providence (hereinafter sometimes called the "City," "City of Providence" or "Providence") to establish the Providence Review Commission to assist in:

(1) Ensuring the fiscal solvency of the City of Providence through the improvement of local financial management and the avoidance of financial obligations that exceed the capacity of the city;

(2) Ensuring effective management and spending controls on Providence city government;

(3) Reviewing and recommending correction of any deficiencies in said city's fiscal management.

Sec. 21-142. Creation of review commission.

(a) The City Council hereby establishes the Providence Review Commission (hereinafter referred to as the "commission") for the purpose of monitoring the management of the financial affairs of the City of Providence.

(b) The commission shall be composed of thirteen (13) members having the qualifications and/or offices set forth below and selected in the following manner: Eight (8) members to be selected by the City Council on the recommendation of the Finance Committee of the City Council. Of the eight (8) members so appointed by the City Council, three (3) shall serve for a term of one year, three (3) will serve for a term of two years, and two (2) will serve for a term of three years.

(c) All subsequent appointments or reappointments made by the City Council shall be for a term of three (3) years. Of the eight (8) members of the Commission appointed by the City Council, one (1) member shall be a practicing attorney; one (1) member an independent certified public accountant; one (1) member shall be engaged in business, banking or finance; one (1) member shall be a member of a labor union; one (1) member shall have experience in the study of or a profession related to governmental finance; and three (3) members shall be a representative of the general public. None of the members of the commission so appointed shall be an elected or appointed officer or an employee or paid consultant of the City of Providence, or any of its departments, boards, agencies or commissions other than as a member of the Providence Review Commission.

(d) The remaining five (5) members shall serve at the pleasure of the appointing officer and shall be selected as follows: One (1) member to be selected by the Mayor of the City of Providence; one (1) member to be selected by the Governor of the State of Rhode Island; one (1) member to be selected by the speaker of the Rhode Island House of Representatives; one (1) member to be selected by the majority leader of the Rhode Island Senate; and the Auditor General of the State of Rhode Island, who shall serve as a member, ex officio.

(e) Each member of the commission, other than the Auditor General, shall be a qualified elector and resident of the City of Providence.

(f) The chairperson of the commission shall be selected by the commission from its membership, and the commission shall adopt by-laws and rules of procedure consistent with the Providence Home Rule Charter and the Code of Ordinances.

Sec. 21-143. Authority of the commission.

The Commission is hereby authorized and empowered to take any of the following actions with respect to the City of Providence:

(1) To make an analysis of all factors and circumstances contributing to the financial condition of the City of Providence and to recommend steps to be taken to correct any deficiencies in such conditions.

(2) To monitor and review expenditures against the total amount of appropriations of any fiscal year.

(3) To monitor the estimates of revenues to fund any fiscal year operating budgets of the City of Providence and to monitor the receipt and collection of those revenues.

(4) To require and prescribe the form of special reports to be made by the City of Providence finance director, internal auditor, city collector,

city controller and any department directors or other officers or employees of the city to keep the commission continually informed of the financial affairs of the city.

(5) To review and make recommendations regarding:

(a) Bidding or purchasing procedures and decisions;

(b) Investments, loans or borrowings by the city or any of its departments or agencies; and

(c) City accounts and methods of administration of such accounts;

(d) Personnel staffing levels;

(e) Contracts by and between any third party and the city; and

(f) Any collective bargaining agreement between any union and the city.

(6) To coordinate its activities with any management, reorganization or efficiency studies of all or any portion of the city's operations which may be conducted at the request of or under the sponsorship of the mayor, finance committee of the city council, the city council or the finance director. In the event that the mayor, the city council, the finance committee of the city council or any city department director proposes or requests a reorganization of any city department or operation or any efficiency, cost-saving or management study of any city operations within its, his or her jurisdiction, the commission shall assist in carrying out such study and shall report its evaluation of the proposed reorganization or management efficiency or cost-saving measures.

The Commission may recommend that the City Council investigate, pursuant to the authority set out in Sections 402 and 403 of the Providence Home Rule Charter of 1980, as amended, any alleged violation of law brought to the attention of the City Council by the Commission.

Sec. 21-144. Cooperation.

All departments, employees, agencies, and elected and appointed officers of the City of Providence shall cooperate with the commission. The commission shall have access to all records and books of account of the city. The commission may recommend that the city council conduct an investigation pursuant to Sections 402 and 403 of the Providence Home Rule Charter of 1980.

Sec. 21-145. Operation of the Commission.

The members of the commission shall receive no salary, but may receive such per diem allowance as may be appropriated by the city council and shall be reimbursed for their ordinary and necessary expenses incurred in carrying out their duties as members of the commission provided such members are not, at the time such expenses are incurred, public employees otherwise entitled to such reimbursement. Such reimbursement shall also be subject to the commission's rules and city payment and fiscal procedures. The commission is authorized to employ such consultants, experts, legal counsel and other persons subject to the prior approval of the City Council. The finance director, city treasurer and internal auditor shall assist the commission in carrying out its responsibilities by providing services and facilities for the commission; provided, however, that provision of said services and facilities by the finance director, city treasurer and internal auditor shall be subject to the performance of other duties as set forth in said Providence Home Rule Charter of 1980, as amended.

Sec. 21-146 Reports by the commission.

The commission shall make a semianual report to the general assembly, governor, the city council, finance director, mayor and members of the commission on or before each January 31st and July 31st of each year regarding its findings and recommendations for the six-month period ending thirty-one (31) days before each such date. All actions of the Commission shall be advisory only and shall be consistent with the provisions

of the Providence Home Rule Charter of 1980, as amended, and the Providence Code of Ordinances, and no action of the mayor, the City Council or any City officer, employee, board or commission shall be made void by any action of the commission.

Sec. 21-147 Prohibitions; penalties, disciplinary action, etc.

Any city employee or officer who willfully violates or fails to comply with any request of the commission which is within the commission's authority and any city employee or officer who willfully prepares, presents or certifies and document, instrument, agreement or information, including without limitation any projections or estimates of revenue or expenditure requested by the commission or any agent or employee of the commission, known to be false or misleading or knowing the same omits to state a material fact or if any such person, upon learning that any such document, instrument, agreement or information is false, misleading or omits to state a material fact, fails promptly to advise the commission thereof, shall be reported to the City Council.

Section 3. This Ordinance shall take effect upon its passage.

An Ordinance establishing a Tax Stabilization Plan for Laurelmead Nursing Center, L.L.C., as amended.

Be it Ordained by the City of Providence:

Whereas, Section 21-169 of the Ordinances of the City of Providence grants authority to the City Council, pursuant to Section 44-3-9 of the General Laws of the State of Rhode Island, as amended, to exempt property used for industrial or commercial purposes from the payment of property tax if the granting of the exemption meets certain conditions set forth in said Section of the Ordinance; and

Whereas, Laurelmead Nursing Center, LLC has made application under, and has satisfied each condition of the above-mentioned Ordinance; and

Whereas, Laurelmead Nursing Center, LLC plans to locate and construct in the City, a new commercial concern, to wit: a new health care facility consisting of 89 new assisted living apartments, a 60-bed nursing center and a physical rehabilitation center located at 355 Blackstone Boulevard, Providence, Rhode Island 02906, on a portion of Assessor's Plat 38, Lot 79 ("Project"); and

Whereas, The Project will cause an increase in the tax base of the City and will increase employment opportunity in the City; and

Whereas, It is in the interest of the residents of the City of Providence to grant such an exemption to induce the development and construction of the Project in the City, and such exemption will inure to the benefit of the City;

Be it Ordained by the City of Providence:

Section 1. That the findings set forth in the preceding WHEREAS Clauses are hereby made and confirmed.

Section 2. As long as Laurelmead Nursing Center, L.L.C. owns or operates the facility it will continue to pay taxes on the facility. Laurelmead Nursing Center, L.L.C. also agrees not to transfer the property to a tax-exempt entity or to allow any transfer by any subsequent transferee to a tax-exempt entity during the term of the tax treaty. Laurelmead Nursing Center, L.L.C. agrees to ensure that any transferee or successor will be an entity required to make payments under the tax treaty during the term of the tax treaty. Laurelmead Nursing Center, L.L.C. is also required as a condition precedent to this tax treaty to record notice of the requirement that the property covered by this Ordinance be transferred only to a tax-paying entity, as set forth herein, in the Land Evidence Records or the City of Providence, during the term of the tax treaty. In

the event that the property covered by this Ordinance is transferred to a tax-exempt entity, whether by Laurelmead Nursing Center, L.L.C. or any subsequent transferee of such property, during the term of the tax treaty, Laurelmead Nursing Center, L.L.C. will require any such transferee to make said payments or Laurelmead Nursing Center, L.L.C. will be responsible to make payments in lieu of taxes to the City of Providence equal to the amount of taxes which would have been paid to the City of Providence if such prohibition against transfer to a tax-exempt entity had not been violated. Notwithstanding anything to the contrary herein or in the tax treaty used in connection herewith, the provisions of this Section 2 shall continue to be given full force and effect during the term of the tax treaty until such time as the same shall be amended or terminated by majority vote of the City Council of Providence.

Section 3. It shall be the goal of Laurelmead Nursing Center, L.L.C. to award to Minority Business Enterprises as defined in Rhode Island General Laws, Section 37-14.1 ("MBE Act") no less than 10% of the dollar value of the construction costs for the Project (as determined in accordance with the rules and regulations promulgated pursuant to the MBE act). It shall be Laurelmead Nursing Center, L.L.C.'s further goal to award to woman business enterprises (WBE) no less than 10% of the dollar value of the construction costs for the project (as determined in accordance with Section 21-52 of the Code of Ordinances of the City of Providence). It shall be a further goal of Laurelmead Nursing Center, L.L.C. to achieve a minimum level of 10% for minority and 10% for female employment.

Section 4. In making employment decisions, Laurelmead Nursing Center, L.L.C. shall give preferential consideration to qualified employees/applicants who reside in Providence.

Section 5. The schedule listed below is based upon information provided to the Tax Assessor by Laurelmead Nursing Center L.L.C, including, but not limited to, estimated construction costs. In the event any of this information is inaccurate

or proves to be erroneous, this treaty shall be modified to reflect the accurate information.

Section 6. The Laurelmead Nursing Center, L.L.C. has agreed to make two payments of thirty-six thousand one hundred and fifty dollars and fifty-six cents (\$36,150.56) to the City of Providence. The first payment shall be made prior to June 30, 1996, the second payment shall be made prior to June 30, 1997, and the third payment shall be made prior to June 30, 1998.

Section 7. That the real and personal property taxes payable to the City by the Project during the term of this Ordinance shall be based upon the real and personal property tax rates in effect for the City's 1996 fiscal year.

Section 8. That the City, in accordance with Section 44-3-9 of the Rhode Island General Laws and Section 21-169 of the Code of Ordinances for the City of Providence, is hereby authorized to grant an exemption from the assessed valuation for tax purposes as of December 31, 1997 up to and including December 31, 2006 to Laurelmead Nursing Center, LLC located at 355 Blackstone Boulevard, Providence, Rhode Island 02906, on a portion of Assessor's Plat 38, Lot 79, as provided in the above-mentioned Ordinance, in accordance with the following schedule:

Section 9. This Ordinance shall take effect upon its passage.

An Ordinance in Amendment of and in addition to Chapter 1977-15 of the Ordinances of the City of Providence, approved April 28, 1977 entitled: "An Ordinance approving and adopting the Official Redevelopment Plan for Federal Hill East" for additional acquisition.

Be it Ordained by the City of Providence:

1. That Chapter 1977-15 of the Ordinance of the City of Providence, approved April 28, 1977,

entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the Federal Hill East Project" as amended by the following Ordinance of the City of Providence: Chapter 1977-48, approved December 9, 1977, Chapter 1979-2, approved January 22, 1979, Chapter 1980-26, approved May 3, 1980, Chapter 1981-6, approved February 26, 1981, Chapter 1990-4, approved February 8, 1990, and Chapter 1992-45, approved November 25, 1992 of the Ordinances of the City of Providence is hereby further amended as follows:

A. Add the following lots to the acquisition list in Section 2. entitled "Proposed Acquisition" under Chapter E entitled "Plan Proposals" contained and set forth on Page 15 of the certain booklet entitled, "Federal Hill East, Official Redevelopment Plan, 1977" which is part of the aforementioned Ordinance as amended to date:

3. This Ordinance shall take effect upon passage and the City Clerk shall forward a certified copy to the Providence Redevelopment Agency.
