





RELATING TO TOWNS AND CITIES -- POLICE OFFICERS AND FIRE FIGHTERS

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 45-2-15 of the General Laws in Chapter 45-2 entitled "General
2 Powers" is hereby repealed.

3 ~~45-2-15. Police officers and fire fighters. — No city or town shall require that an~~
4 ~~individual reside within the city or town as a condition for appointment or continued employment~~
5 ~~in its police or fire department.~~

6 SECTION 2. Chapter 45-2 of the General Laws entitled "General Powers" is hereby
7 amended by adding thereto the following section:

8 **45-2-15.1. Police officers and firefighters -- Residency within municipality not**
9 **required. — Notwithstanding any prior ratification and validation by the general assembly of any**
10 **home rule charter provision requiring that police officers and fire fighters reside within the**
11 **employing city or town, no home rule charter provision shall require that a police officer or fire**
12 **fighter reside within the city or town as a condition of appointment or continued employment.**
13 **Any prior ratification and validation by the general assembly of a home rule charter provision**
14 **requiring residency within a city or town as a condition for employment of a police officer or fire**
15 **fighter is hereby expressly repealed by the general assembly; further, no city or town council shall**
16 **make or ordain any ordinance requiring a police officer or fire fighter to reside within the**
17 **employing city or town as a condition of appointment or continued employment. Any existing**
18 **ordinance requiring a police officer or fire fighter to reside within the employing city or town as a**
19 **condition of appointment or continued employment is hereby considered contrary to the laws of**

1 this state and is thus void as being in violation of state law.

2 SECTION 3. This act shall take effect upon passage.
