Bureau of Licenses is hereby authorized to appoint the Chief of the Division of Minimum Standards Housing, and Certain Renewal Inspectors, designated by the said Chief, as Constables, for the purpose of service of summons issued by a Justice of the Providence Municipal Court, for violations of the said Section 13," as amended

Resolution Authorizing the Mayor and the Committee on City Property to Negotiate with Providence College for the Purchase and Sale of the Charles V. Chapin Complex.

Whereas, The State of Rhode Island has abandoned the Charles V. Chapin Hospital Complex, so called, which was conveyed to the State of

Rhode Island by the City of Providence by deed dated March 26, 1968, and

Whereas, Said deed provided that legal title to said Charles V. Chapin Hospital Complex shall revert to the City of Providence if and when the State of Rhode Island shall abandon the same for curative and convalescent health purposes, and

Whereas, The Committee on City Property has expressed its opinion that said Charles V. Chapin Hospital Complex has become unsuitable for use of any public purpose or purposes and has ceased to be used for such purposes, and

Whereas, By Resolution of the City Council No. 565, approved November 11, 1974, the City of Providence accepted the reversion of said Charles V. Chapin Hospital Complex and declared the same unsuitable for hospital purposes or for any public purpose or purposes, and

Whereas, A public hearing, pursuant to petition, was held by the Committee on City Property on Thursday, November 14, 1974, at which no testimony or other evidence was offered,

Now, Therefore, be it Resolved, That the Mayor and the Committee on City Property be and they hereby are authorized to conduct negotiations looking to a private sale of said Charles V. Chapin Hospital Complex to Providence College for a consideration equal to the fair market value thereof.
