ORDINANCE SECOND READING

The following Ordinance was in City Council October 21, 1999, Read and Passed the First Time and is returned for Passage the Second Time:

An Ordinance in amendment of Chapter 17 of Article VI of the Code of Ordinances of the City of Providence entitled "Retirement System".

Be it ordained by the City of Providence:

Section 1. Chapter 17 of Article VI of the Code of Ordinances of the City of Providence shall be amended by adding the following:

Sec. 17-189.1 — Honorable Service, revocation or reduction of retirement benefits of employees committing crime related to public employment.

(a) *General provisions.*

(1) Payment of an employee's retirement allowance or annuity or other benefit or payments as provided in Chapter 17 shall be for honorable service only.

(2) For purposes of this section, "crime related to his or her public employment" shall mean any of the following:

a. The committing, abiding or abetting of an embezzlement of public funds;

b. The committing, aiding or abetting of any felonious theft by a public employee from his or her employer;

c. Bribery in connection with employment of a public employees; and

d. The committing of any felony by a public employee who willfully, and with the intent to defraud, realizes or obtains, or attempts to realize or obtain, a profit, gain, or advantage for himself or herself or for some other person through the use or attempted use of power, rights, privileges, duties, or position of his or her public office or employment.

(3) For purposes of this section, "public employee" or "employee" shall mean any current or former city elected official, or any appointed official or employee of the city, or of a city board, commission or agency, who is otherwise entitled to receive a retirement allowance or annuity or other benefit or payment of any kind pursuant to Chapter 17.

(4) *Revocation or reduction authorized.* Notwithstanding any other provision of law, any retirement allowance or annuity or other benefit or payment of any kind which an employee is otherwise entitled to under Chapter 17 shall be revoked or reduced in accordance with the provisions of this section if such employee is convicted of or pleads guilty or nolo contendere to any crime related to his or her public employment. Any such conviction or plea shall be deemed to be a breach of the employee's contract with his or her employer.

(5) *Hearing; civil action.* Whenever any employee is convicted of or pleads guilty or nolo contendere to any crime related to his or her public employment, the Retirement Board shall

conduct a meeting, with the employee having the opportunity to be heard, to determine if a recommendation of revocation or reduction of any retirement allowance or annuity or other benefit or payment to which the employee is otherwise entitled to under this chapter is warranted. If the Retirement Board determined that revocation or reduction of any retirement allowance or annuity or other benefit or payment to which the employee is otherwise entitled to under this chapter is warranted, the Retirement Board shall initiate a civil action in the Superior Court for the revocation or reduction of any retirement allowance or annuity or other benefit or payment to which the employee is otherwise entitled to under Chapter 17.

(6) For purposes of this section, "pleads guilty or nolo contendere" shall not include any plea of guilty or nolo contendere which does not result in a conviction by virtue of G.L. 1956 § 12-10-12 or 12-18-3, as amended.

Section 2. This Ordinance shall take effect upon passage.

Three (3) Community Leaders

One (1) Job Training Professional

Two (2) Drug Rehabilitation Professionals

One (1) Superintendent of Schools or Designee

Whereas, The residents of the City of Providence are requesting that SWAP (Stop Wasting Abandoned Property) inform the communities of any proposed plans by way of holding public hearings which would be advertised in local and community papers.

Now, therefore, be it Resolved, That the Providence City Council place a Ninety (90) Day Moratorium on any and all land to be acquired by SWAP (Stop Wasting Abandoned Property) throughout the City of Providence until such time as they hold a public hearing on any and all existing and proposed projects,

and that all tax abatements and building permits be placed on hold, if such public hearings are not held within the Ninety (90) Days, said Resolution shall be extended.

Be it further Resolved, That SWAP (Stop Wasting Abandoned Property) respond in writing to the Providence City Council as what it intends to do about these problems within Ninety (90) Days of the passage of this Resolution.

"A lot of times when we talk about our schools, we talk about negative things that have happened, but at this point it is unfortunate that the Journal is not here, I think all we need to be aware of some positive things that never get publicity, or enough publicity, within the schools that I would like to make my colleagues aware of. Two of them being sports related within this fall season, the Classical Girls' Tennis Team won the State Championship, and also the Hope High School Boys' Soccer Team won the State Championship, and I think that at a further time we should honor both teams. Probably numerous members of those teams come from all of our communities, or some of our communities. I think that is important because we don't give them enough recognition, nor does the Journal Bulletin give the young people who take the extra time to participate in extra curricular activities. The third thing in regard to the schools . . . it relates to the performing arts. We hear all the time about the creation and the future of performing arts school, but we already have a performing arts school as we know, and that is the Hope

High School Arts Magnet which has done a wonderful job. I just want to make my colleagues aware of that they were one of 24 schools chosen, their theater group, to perform at the Edinburrow Festival in Scotland in the spring. The play they will be doing is Rowing to America, the Immigrant Project, and they will be performing at Hope on December 2 and 3. They are one of only 24 schools. It is like the Olympics of theater production. One of only 24 public or private schools within the United States chosen to perform at this festival. They obviously need to raise funds. I would encourage my colleagues to call either the person who is the director, Ms. Auxier who is in charge of the theater production, or the principal. I think that instead of raising funds for the performing arts school, support the performing arts school that we already have and give money towards what they have already achieved. They all have to be recognized nationally and we need to promote that more than we have and not say we don't have anything going on in the arts within our high schools, but we already have something positive and unless we can stand behind that, I don't think the children will appreciate our efforts."
