ORDINANCES SECOND READING

The Following Ordinances were in City Council April 25, 2005, Read and Passed the First Time and are Severally Returned for Passage the Second Time:

An Ordinance Adding Section 15-14 in the Code of Ordinances Entitled: "Motor Vehicles and Traffic".

Be it ordained by the City of Providence:

SECTION 1. The Code of Ordinances of the City of Providence is amended as follows:

Sec. 15-14. Parking Meters—Multi-Space Parking Meters and Spaces.

- (a) A multi-space meter is a device installed by the City for acceptance of required parking fees for more than one parking space. A multi-space meter may regulate multiple parking spaces on-street (curbside or angled spaces) or off-street (parking lots or garages.) Use of a multi-space meter may require a motorist to display a receipt on the curbside window or curbside dashboard of their vehicle, or may require a motorist to enter a space number in conjunction with making a payment. Multi-space meters may accept a variety of payment options, which may include coins, credit cards or stored value cards, such as smart cards. At all times, payment in advance is required at any single meter or multi-space meter.
- (b) Multi-space meter spaces are defined as any parking space, designated or not, where at least one posted sign states requirement for payment at a multi-space

meter. Multi-space meter spaces may not be adjacent to a multi-space meter, but shall be in close proximity to the parking space.

- (c) Multi-space meters shall operate in one of the following ways: for street parking, the motorist shall park their vehicle, proceed to the nearest meter, pay the required parking fee, then return to their vehicle to affix and display the paid receipt at the curbside window of the vehicle; for off street parking in garages and lots, the motorist shall park their vehicle, proceed to the nearest meter, enter their space number and then pay the required fee. Depending on the type of configuration, a receipt may or may not be issued.
- (d) No operator of a vehicle, upon entering a multi-space meter regulated space, shall fail to immediately deposit the required fee for regulated parking, and return to display the receipt.
- (e) When parking on a block regulated by multi-space meters and the nearest meter is out of order or cannot issue a receipt, payment shall be made at the next available multi-space meter on the block.

SECTION 2. This Ordinance shall take effect upon its passage.

An Ordinance Requiring the mailing and posting of notices in English and other languages.

Be it ordained by the City of Providence:

Whereas, a substantial percentage of the population of the City of Providence has a first language other than English; and

Whereas, It is very important that residents be able to understand notices related to such important matters as zoning, licenses, and historic districts, amongst others.

Now, Therefore, Be It Enacted As Follows:

Section 1.

- (a) All notices that the city or any of its agencies requires to be sent to designated members of the public regarding matters including, but not limited to, licensing, zoning or historic districts, must be provided in both English and in all languages that are the first languages of more than 10% of city residents, as determined by the United States Census Bureau.
- (b) Notices that the city or any of its agencies, or any applicant, publishes in a newspaper of general circulation shall be printed in English, but shall include the title, as well as a sentence in distinctive print, in all languages that are the first languages of more than 10% of city residents, as determined by the United States Census Bureau, and shall include a phone number that may be called for translation into those languages.
- (c) When such notices or mailings invite the recipients' or readers' attendance at a

hearing or other meeting, such notice shall provide that, upon 24 hours advance request, the city shall make its best efforts to have a translator available to translate the meeting into any language that is the first language of more than 10% of city residents, as determined by the United States Census Bureau.

- (d) The city shall not be liable for any mistranslations.

Section 2: This ordinance shall take effect on September 1, 2005.

An Ordinance in Amendment of Chapter 1994-52, As Approved December 27, 1994, Entitled: "An Ordinance Adopting Providence 2000: "The Comprehensive Plan as the City's Comprehensive Plan to direct the development of the City, As Amended".

Be it ordained by the City of Providence:

That Chapter 1994-52, No. 798, approved December 27, 1994, also known as *Providence 2000: The Comprehensive Plan*, (hereinafter referred to as "Plan") is hereby amended, pursuant to Rhode Island General Laws Section 45-22.2-12. The following sections shall be considered to be a single action to amend to the Plan.

Section 1 - To adopt the plan entitled "**Strategy for Reducing Risks from Natural Hazards in Providence, Rhode Island, 2004**" as Plan Number 5 of the Comprehensive Plan Series of *Providence 2000: The Comprehensive Plan*, attached and made part of this Ordinance.

Section 2 - This Ordinance shall take effect upon passage.
