RESOLUTION OF THE CITY COUNCIL

No. 108

Approved February 9, 1979

WHEREAS, The City of Providence now has a financial deficit of more than 7.5 Million Dollars, and

WHEREAS, A Budget will be submitted to the City Council for the fiscal year, 1979-1980 for their study and passage,

NOW, THEREFORE, BE IT RESOLVED, That a Blue Ribbon Committee consisting of Nine (9) Members be created to study the financial status of the City to be appointed within Fifteen (15) Days following passage and approval of this Resolution as follows:

Three (3) Members to be appointed by the Mayor
Three (3) Members to be appointed by the City Council
Three (3) Members to be appointed by the Director of the Rhode Island Expenditures Council, and

BE IT FURTHER RESOLVED, That said Blue Ribbon Committee shall report back to the City Council the financial status of the City no later than April 1, 1979 and if possible, what they determine is anticipated as of June 30, 1979, and

BE IT FURTHER RESOLVED, That said Blue Ribbon Committee recommend new procedures to follow to keep the City in sound financial condition.
