Resolved,

That all Departmental Heads be and they are hereby authorized to permit leaves of absence without loss of compensation for employees of the City of Providence in their respective Departments who served in the Armed Forces of the United States of America, and have been honorably discharged following their service, and who are members in good standing and desire to attend the Annual Conventions of their respective Veteran's Organizations as follows:

The Annual Encampment of Veterans of Foreign Wars in Milwaukee, Wisconsin from August 2, to August 7, inclusive;

The American Legion National Convention in St. Louis, Missouri from, August 30, to September 4, inclusive;

The Annual Convention of Disabled American Veterans in Kansas City, Missouri from August 23, to August 28, 1953 inclusive;

The National Convention of American Veterans of World War II (Amvets) in Indianapolis, Indiana from September 3, to September 6, 1953 inclusive;

The National Convention of Italian American World War Veterans of the United States, Inc., in Boston, Massachusetts on September 4, 5, 6 and 7, 1953 inclusive;

The National Convention of Jewish War Veterans in Chicago, Illinois from September 2, to September 6, 1953, inclusive;

The National Convention of the Marine Corps League (Date and Place to be announced later);

The Fifty-fifth National encampment of the United States Spanish War Veterans in Cleveland, Ohio from August 30, to September 3, 1953, inclusive;

BE IT FURTHER RESOLVED, That a Special Committee of the City Council consisting of three members, thereof, be and the same is hereby created to be appointed by the President of the City Council for the purpose of verifying the war service records and membership standing in the various above listed Veteran's Organizations of said employees who apply for such leaves of absence.
