M I N U T E

ARTHUR A. THOMAS, a native of this city, was born June 13, 1878, the son of the late Charles L. and Sarah (Barstow) Thomas.

A practicing attorney for more than fifty-seven years, Mr. Thomas received his early education at Mowry Goff Academy here and was graduated from Phillips Academy in Andover, Mass. in 1897, from Yale University in 1901 and from Harvard Law School in 1904. Although his interests were many and varied, he gave of his time and talents to his native city many years of devoted service, serving as Councilman from the second ward from 1919 to 1937 and for nearly twenty-two years as a member of the Zoning Board of Review - a record of public service seldom, if ever, equalled.

Mr. Thomas' communal interests had many facets and his host of associates in the business, civic, cultural, fraternal, philanthropic and religious life of this community though they now mourn the loss of an illustrious citizen and public benefactor will always cherish their kindly association with him.
