


RESOLUTION OF THE CITY COUNCIL

No. 602

Approved October 25, 1995



WHEREAS, economic development in the City is essential for the creation of jobs for City residents and the stabilization of the city's tax base;

WHEREAS, many economic development projects need federal, state and/or local assistance;

WHEREAS, the Rhode Island Overall Economic Development Program (OEDP) is a listing of projects that are eligible for federal assistance through the Economic Development Administration;

WHEREAS, it is in the city's interest to insure that projects that create short and long term jobs and help the city meet neighborhood needs are eligible for federal assistance by requesting that the projects be listed in the Rhode Island Overall Economic Development Program;

NOW, THEREFORE, BE IT RESOLVED that the following projects be re-submitted to the Planning Division of the Rhode Island Department of Administration for inclusion in the 1995 Rhode Island Overall Economic Development Program:
