The Providence Redevelopment Agency, in accordance with the provisions of Paragraph 10, Chapter 1971-24 of the Ordinances of the City of Providence approved May 10, 1971 as amended by Chapter 69-47 of the Ordinances of the City of Providence approved November 28, 1969 and Title 45, Chapters 31-33 of the General Laws of Rhode Island 1956, hereby reports concerning the proposed sale of real property within the West Broadway NDP, A2-1, Year II.








Area = 4,000 ± Sq.Ft.
