AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1984-53 APPROVED JULY 20, 1984, BY TRANSFERRING EIGHT THOUSAND DOLLARS (\$8,000.00) FROM PUBLIC PARKS TO THE RECORDER OF DEEDS.

Be it ordained by the City of Providence:

SECTION 1: CHAPTER 1984-53 of the Ordinances of the City of Providence, as approved July 20, 1984, entitled: "An Ordinance making an Appropriation of One Hundred Seventy-One Million, Fifty Six Thousand, One Hundred Seventy-Seven Dollars and Fifty Seven Cents. (\$171,056,177.57) for the fiscal year ending June 30, 1985, as amended", is hereby amended by transferring the sum of Eight Thousand Dollars (\$8,000.00) from the Public Parks division of Development and Environmental Services to the Recorder of Deeds. This transfer would be effected as follows:

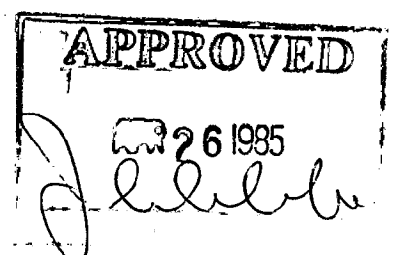


