Dear Mr. Flynn,

I recently met with Mr. John M. Cronin, Chief, R.I. Division of Fish and Wildlife, at the City of Providence summer camp (Camp John P. Cronin), concerning accessibility and parking at about fifty yards north of the shore point of the East Breakwater, Point Judith Harbor of Refuge.

His major concern was accessibility to this state owned parking area from either Ocean Avenue, in which case fishermen would be levied a two dollar fee for traversing private property, or through Camp Cronin. The best access is from the eastern end of the camp's main road. This main road connects with the Town of Narragansett's Point Judith Road.

The state will remove existing barriers, grade and build a one lane road to the parking area in question. There will be no cost to the City of Providence.

Considering all of the many positive factors involved, I find as Director of the Providence Recreation Department no reason, recreationally, to object to the above mentioned access road.
