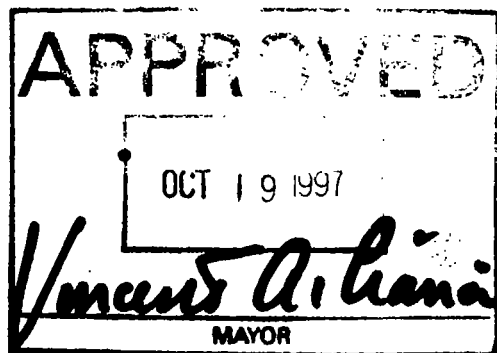

*Approved* October 19, 1997

WHEREAS, Judge William G. Grande, a lifelong resident of the City of Providence died at the age of 90 on September 26, 1997, and

WHEREAS, Judge Grande was a lawyer for more than sixty years and had his own practice and was also a Probate Judge, and

WHEREAS, Judge Grande worked in many high level positions, such as State Representative, a Special Assistant Attorney General in the Crime Prevention Bureau where he founded the Providence Crime-Prevention Program, and

WHEREAS, Judge Grande was a member and leader of many civic organizations within the State of Rhode Island, and

WHEREAS, In 1993, at the age of 87, he was appointed a Providence Municipal Court Judge, becoming the oldest sitting Judge until his death at age 90, and

WHEREAS, Also in 1993 he was the oldest Judge ever to attend the National Judicial College, since the college was founded in 1963, and

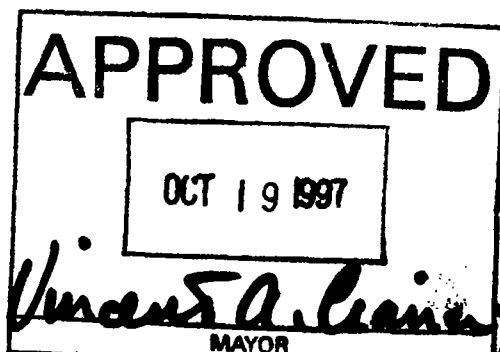

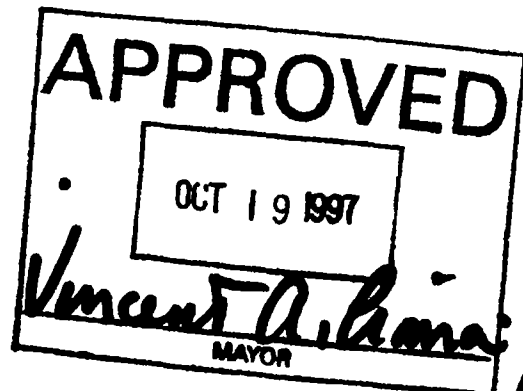
