



Matt Brown Web site adds features

The secretary of state's announcement comes at a time when a long-promised online "Town Crier" addition is months behind schedule.

PROVIDENCE -- Secretary of State Matt Brown is promoting the start of a new "data-sharing initiative" that will allow more sophisticated Internet users to track new information added to his Web site and other government locations.

His announcement comes at the same time as another long-touted venture, a promise to create an "Electronic Town Crier" to collect and publicize municipal meeting notices, is finally nearing its debut, months behind schedule.

The new effort from Brown's office is dubbed "RSSonate" (pronounced "resonate"). It is a play on words on an Internet-wide system known as RSS, short for "Really Simple Syndication," that some Web users customize to collect information on everything from news services to online "blog" journals, as they are updated.

Brown spokesman Paul Tencher said staffers in the secretary of state's office have created programming that will allow government information to be distributed in the same manner.

The RSS information-feed program they created is already in use by both Providence and Middletown, meaning computer users can follow links off those municipal Web sites to request updates when, for example, a new local meeting is posted, he said.

Ultimately, Tencher said, the system will also allow users to track changes to databases on Brown's own Web site, such as new business incorporations or registered lobbyists, and to customize what information they receive.

The first piece of that will go hand in hand with the long-promised town meetings database, now scheduled to debut late tomorrow, Tencher said.

In 2003, his first year in office, Brown successfully worked to pass legislation requiring cities and towns to begin sending all local meeting notices, agendas and minutes to his office over the computer. The initiative, Brown said, would enable him to set up a centralized meeting list on the Internet, and let computer users sign up to be notified by e-mail whenever certain types of meetings were posted.

Cities and towns had to begin complying with the legislation last July. At the time, Brown promised his town crier system would be up and running by early fall. More recently, his Web site promised a January rollout.

Tencher said the project was delayed because staff had to turn their focus to implementing new lobbying laws passed in the last legislative session, including creating an online lobbyist-registration system.

While the information that cities and towns have been sending in was not posted online, Brown's staff used it to answer any related e-mail inquiries in the interim, he said.

Other databases on Brown's site, such as the list of registered lobbyists or incorporated businesses, will also be trackable through the RSS system by the end of 2005, Tencher said.

While the online lobbyist-registration system was up and running at the start of the year, it was not until early February, roughly five weeks after lawmakers reconvened, that the current-year database was posted on his Web site for easy public access.

Journal reporters quickly noticed that some lobbyists they had spotted at the State House -- such as those representing gambling giant Harrah's and its casino plans -- were not yet listed.

Tencher's explanation is that lobbyists are not placed into the online database until they have completed the registration process by both paying the \$5 fee and picking up their identification badge.

Monthly lobbyist spending reports will also be online, Tencher said, starting next month; the first reports are due March 15.

Tencher could not say yesterday when another feature of Brown's Web site would be ready for the current legislative cycle: a function called "BillTracker" that lets a user create a list of bills, then follow their progress by returning to a customized report on Brown's Web site.

Right now, users who go to "BillTracker" find only the previous year's sessions available. Tencher said Brown's staff is working with the legislature to get the tracking system up and running for 2005 "as fast as possible."

Brown, a Democrat, recently announced he would be a candidate in the 2006 election for the U.S. Senate seat held by Republican Lincoln Chafee.


