Two sites have been completed, Daniel Ave. Playground and Knight and Tell St. Playground. Regarding the Hartford Park Development Project, as you are aware that is an entirely separate department, so that request would have to be handled at their level.

A further check with the Narragansett Electric Co., which installs the floodlights for our recreation uses revealed that they can not install any lightning at that particular site for it is private property with privately owned poles.
