WHEREAS, Many minimum housing code violators are adjudged in contempt of court, and

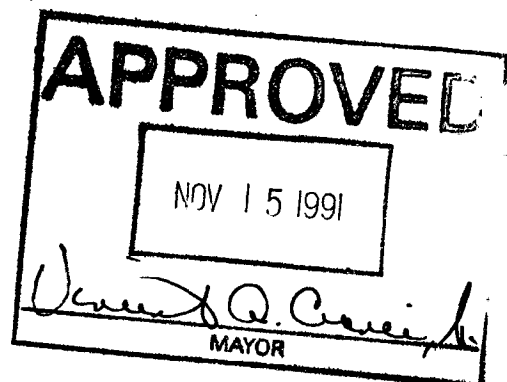
WHEREAS, Providence Housing Court Justices have ordered Body Attachments on people who are in contempt of court, to be brought into court, and

NOW, THEREFORE, BE IT RESOLVED, That the Chief of the Providence Police Department, in co-operation with the Justices of the Providence Housing Court, and the Department of Code Enforcement, to appoint a task force to serve long outstanding "Body Attachments" within the State of Rhode Island with regard to Housing Violations.

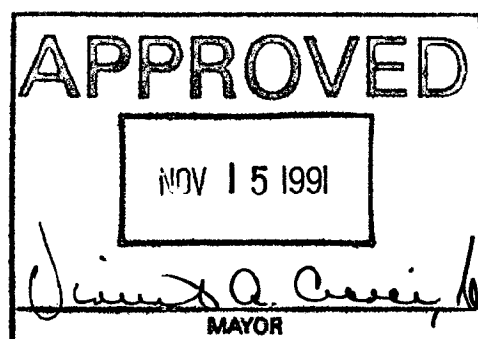
