ORDERED, That the Superintendent of Street Signs and Numbers be and he is hereby directed to cause a sign to be placed on that unnamed Gangway from Judith Street to Huldah Street, abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence, at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting that unnamed Gangway from Judith Street to Huldah Street, which has been abandoned, who is known to reside within this State.

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, September 8, 1959.

This referral is a request to abandon a certain unnamed alley running from Judith to Huldah Streets in Providence; said alley intersecting Judith Street approximately one hundred and ten feet northwesterly of Sterling Avenue and being further described as that certain alley or way abutted by Lots 207, 208, 210 and 211 on City Assessor's Plat 105.

On an inspection survey it was found that the area in question is landscaped, but otherwise unpaved or uncurbed.

Since the abandonment of the unnamed alley will not conflict with any general or long-term plans of the City's development and it is unlikely that the unnamed alley will be curbed or paved,






