That the following Minute on the life and character of the late Walter Francis Fitzpatrick, former City Treasurer, be and the same is hereby adopted and ordered inscribed on the records of the City Council and a copy transmitted to the family of the deceased.

MINUTE

WALTER FRANCIS FITZPATRICK was born in Providence, February 11, 1888, the son of the late Matthew F. Fitzpatrick and Anne L. (Craddock) Fitzpatrick. From early manhood he was active in the political life of the city. For many years he served as Chairman of the Democratic Ward Committee in the First Ward in the City of Providence. For a long period of time he was associated with the management of the Narragansett Hotel, Providence, and he was also engaged in the real estate business for a time prior to his election as City Treasurer of the City of Providence.

He served as City Treasurer from January 7, 1929 to June 5, 1947. During this period the Finance Department of the City was largely reorganized. He was a candidate for the Democratic nomination for Mayor of the City of Providence in 1940, but failed of nomination in the City Convention by a few votes.

He was an outstanding figure in the charitable, social and fraternal life of the City, and was a leader in establishing social and recreational activities in behalf of the personnel of the Armed Forces of the United States throughout the State of Rhode Island. During World War II he was head of the Recreation and Welfare Committee and gave unstintingly of his time for the welfare of men in the service. He was also chairman of the Community Division of the Rhode Island War Finance Committee.

In fraternal life, he served three times as State Deputy of the Knights of Columbus and was a former Supreme Master of the Fourth Degree Cabot Province which included the New England area. He was a member of Hendriken Assembly, Fourth Degree Knights of Columbus and of Tyler Council and a past president of the Columbus Club. He was a life member of the Providence Lodge of Elks and a member of the Providence Aerie of Eagles. During the war years thousands of people found their way to Roger Williams Park to enjoy and take part in the program known as "Sunday in the Park" planned and directed by Walter F. Fitzpatrick. He also organized the successful Knights of Columbus Charity Ball.

For many years he was Trustee of St. Joseph's Church in Providence and was an organizer of many charitable fund-raising efforts. He was for a time President of St. Vincent's Assembly and Vice-Chairman of Rhode Island Council of Social Agencies.

Walter F. Fitzpatrick was a native son of Providence whose long tenure of service as City Treasurer and whose active participation in the fraternal, charitable, social and cultural life of the City gained for him a legion of friends who now mourn his passing, and

the following named person, firm or corporation is hereby granted permission to erect, alter or use a building or structure at the location named herein for the sale of petroleum, kerosene, gasoline, coal oil and their products, compounds and components as described and shown in and on the application therefor and accompanying plat, all on file in the office of the Inspector of Buildings subject to the conditions that said person, firm or corporation shall not violate any of the laws of the State of Rhode Island or any of the Ordinances of the City of Providence relative to the erection, use or occupation of said structure and that said person, firm or corporation shall not allow petroleum, kerosene, gasoline, coal oil or their products, compounds or components, to be conveyed over or across any sidewalk by means of any pipe or hose, and upon such special conditions as are hereby enumerated, viz:

Ward 13: Benedetto Broccoli, 659 Harris Avenue, Plat 35 Lot 288
1-20,000 Gallon Fuel Oil Storage Tank, making a total
storage capacity of 34,000 gallons upon the premises.

The erection or location of any buildings or structures not shown on the original plat on file with the Inspector of Buildings or any change in the location of buildings or structures from that shown on said plat shall be deemed a violation of this permit.

Dear Sir:

At a meeting of the Zoning Board of Review held on Tuesday, June 24, 1958, the following resolution was adopted:

WHEREAS, Benedetto Broccoli, owner of Lots 288 and 291 on Assessor's Plat 35, 659 Harris Avenue, in an Industrial M-1 Zone, on May 28, 1958, filed an application for permission to install one additional 20,000 gallon underground fuel oil tank in order to increase the total underground storage facilities to 41,000 gallons in all, and

WHEREAS, a public hearing was held on this application by the Zoning Board of Review at its meeting held on Tuesday, June 24, 1958, after public notice as provided by the Zoning Ordinance,

RESOLVED: That the Zoning Board of Review does hereby make a variation of Section 61-A-M under the Zoning Ordinance and does hereby grant the application of Benedetto Broccoli in accordance with the plans and plot plan filed with said Board on condition that Lots 288 and 291 be merged into one lot. A copy of said plans and plot plan are hereby made a part of this resolution and filed with the Director of the Department of Building Inspection.
