Be it ordained by the City of Providence:

SECTION 1. Chapter 1982-42, of the Ordinances of the City of Providence, approved July 7, 1982, entitled: An Ordinance Making an Appropriation of One Hundred Fifty-Eight Million, Two Hundred Thirty-Nine Thousand, Eight Hundred Ten Dollars and Eighty Four Cents (\$158,239,810.84) as amended, is hereby further amended by transferring certain sums of money within the Department of Public Schools as follows:
