No. 659 **AN ORDINANCE** IN AMENDMENT OF SECTION 2-22 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED "SALARY OF MAYOR" AND SECTION 2-23, ENTITLED "SALARIES OF COUNCILMEN, EXPENSE ACCOUNTS."

Approved December 24, 1986

Be it ordained by the City of Providence:

SECTION 1. Section 2-22 of the Code of Ordinances of the City of Providence entitled, "Salary of Mayor" is hereby amended by adding the following paragraph thereto:

"The Mayor shall receive an annual increase in salary in the amount of Five (5%) Percentum per annum; said increase shall take effect on the first Monday in January, A.D. 1987, and thereafter on the first Monday in January, A.D., 1988, and in January, A.D., 1989, and in January, A.D., 1990."

SECTION 2. Section 2-23 of the Code of Ordinances of the City of Providence entitled, "Salaries of Councilmen, Expense Accounts," is hereby amended to read as follows:

"The salary to be paid to the President, the Majority Leader and the Minority Leader of the City Council shall be Eleven Thousand, Five Hundred (\$11,500.00) Dollars per annum, payable in equal monthly amounts."

"The salaries of other members of the City Council shall be Nine Thousand, Five Hundred (\$9,500.00) Dollars per annum, payable in equal monthly amounts."

"Each member of the City Council shall receive an annual increase in salary in the amount of five (5%) Percentum per annum; said increase shall take effect on the first Monday in January, A.D., 1988, and thereafter on the first Monday in January, A.D., 1989, and in January, A.D., 1990."

"Each member of the City Council shall be paid an Expense Account of Two Thousand Four Hundred (\$2,400.00) Dollars per annum, payable at the rate of Two Hundred (\$200.00) Dollars per month."

SECTION 3. This Ordinance shall take effect on the first Monday in January, A.D. 1987, and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.
