the budget and also the personnel involved. When budget cuts are made, they are made with a working knowledge of all areas where specific cuts can be made. The board monitors, on a monthly basis, all expenditures to date and works to keep each expenditure in line with the budget. The school board has retained a surplus each year for the last four (4) years. Approximately \$1,660,000. Presently the budget sub-committee is working toward zero based budgeting.

Sub-Committees: Each board member has been assigned to a sub-committee such as budget and finance, building and grounds, labor negotiations, personnel, school dropouts, curriculum and legislation.

Labor Negotiations: Working with the sub-committee, the Superintendent of Schools and members of the city administrative staff, the school board has been successful in labor settlement. Throughout the process all management prerogatives have been maintained.

Discipline: The board has strengthened the discipline policy in the system taking a no-nonsense approach. Violators of the discipline policy are dealt with fairly, with due process, and harshly. The discipline policy has been amended twice in the last four years.

Educational Needs: Population in schools has increased substantially in the last four years. The special needs population has also increased. Both increases are costly and require various educational programs. The school department has the ability to adjust quickly, and has adjusted to handle the increasing and shifting population. Bi-lingual and special education programs in Providence are the most successful in the North East. As the population grows, space requirements also grow. At present space is a problem. The school department is presently adding an addition to the Asa Messer School, renovations are being done to the Althea Street School, and within the next year work should start on renovating Veazie Street School. Some of these buildings were closed and by reopening them, at a cost much less than new buildings, will ease the space problem that currently exist. A long range plan exists for future space problems as they occur.
