



**Charles “Pops Arlan**

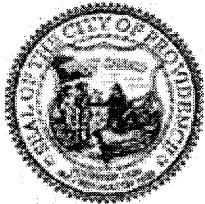
Was a fixture in the concession stand from 1996-2016 when he became ill and was no longer able to do it. Pops was as much a part of the Little League experience for the kids as were the games.
