No. 103

Approved February 7, 1966

WHEREAS, within moments of the receipt of an alarm that six desperate prisoners had overpowered three deputy sheriffs, disarming those carrying weapons and escaped from custody, the Providence Police Department dispatcher put out on the police radio the call that "all cars respond to the Providence County Court House", every available man in this highly efficient law enforcement agency, led by Chief Howard A. Franklin, moved out into action as a unit, to apprehend the escapees, and

WHEREAS, true to the sworn oath that each had subscribed to "zealously guard the constitutional rights of all", and without fear of personal safety or of favor, within twenty three minutes of the alarm, all of the six prisoners were apprehended thus terminating their abortive flight for freedom.

NOW THEREFORE BE IT RESOLVED, That His Honor, Mayor Joseph A. Doorley Jr., and this City Council, mindful of quality of courage displayed by Providences' "finest" take official notice and pleasure to applaud the gallantry of the members of this well trained and oriented law enforcement unit, and further compliment Commissioner Harry Goldstein, Chief Howard A. Franklin and the officers for a grateful populace who can sleep better knowing that their police department is ever alert, and

BE IT FURTHER RESOLVED THAT, the City Clerk is directed to transmit a copy of this expression of appreciation to Commissioner Goldstein so that the personnel of the Providence Police Department be apprised of this tribute.

Allocations toward the City of Providence during 1959-1964 totaled \$36,922,760. The four departments with the largest encumbrances were the Providence Police Department in the amount of \$11,761,511, the City of Providence Department of Public Works in the amount of \$10,761,511, the City of Providence Department of Public Health in the amount of \$10,761,511, and the City of Providence School Department in the amount of \$10,761,511.
