Awareness Week II".

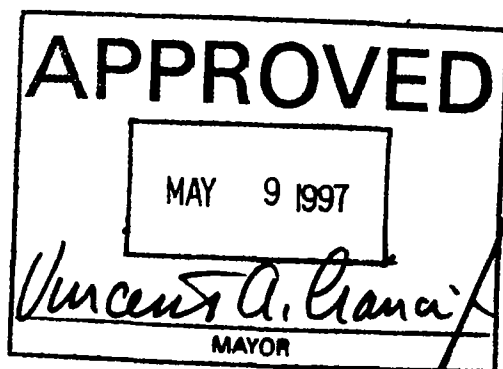

- Whereas; The Children of Central Falls should be safe every second, minute and hour of their precious daily lives.*




