

Re: Change Order 1 Construction Management and Inspection Services

Dear Mayor Taveras:

The Department of Public Works respectfully requests the award of Change Order No. 1 to the "Construction Management and Inspection Services". The Board of Contract and Supply awarded the contract to ten consulting firms on May 6, 2013 in the amount of \$2,000,000. Change Order 1 will increase the contract amount by \$1,100,000 to a revised contract amount of \$3,100,000.

This Change Order 1 is for additional services for the construction management of the Downtown Providence Traffic Circulation Improvements Phase 3, Luongo Square Streetscape Improvements project, the remaining Providence 2013-2015 Road Improvement Program contracts and various sidewalk improvement contracts.

This work will be funded with Providence Public Building Authority funds, RIDOT Reimbursable funds, Road Bond funds and Community Development Block Grant Funds.
