

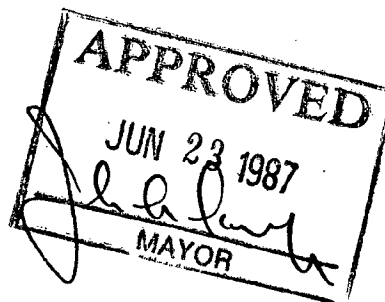

Dear Rose:


We have received the City Council Resolution #414 requesting that the Parks Department cut the grass at the City owned lot at the corner of Mowry Street and Coggeshall Street.

I have investigated this lot and determined that:

1. The lot is littered with abandoned automobiles;
2. The grass is waist high making it impossible to be cut by our machines (it requires a scythe;)
3. The lot, which is officially listed by the Assessor as Plat 70 Lot 244, is owned by a private owner:


