No. 433 AN ORDINANCE Amending Chapter 544 of 1951, by Changing from a C-1 Limited Commercial Zone to a C-4 Heavy Commercial Zone, Lots 351, 352 and 370, as Set Out and Delineated on City Assessor's Plat 98; Said Lots being located along the Easterly Side of Charles Street and Designated as 663-669 Charles Street.

Be it ordained by the City of Providence:

Section 1. The Zoning Map, accompanying and made part of Chapter 544 of the Ordinances of the City of Providence, approved September 21, 1951, entitled: "An Ordinance Zoning the City of Providence and Establishing Use, Height, and Area Regulations, as heretofore amended, is hereby further amended by changing from a C-1 Limited Commercial Zone to a C-4 Heavy Commercial Zone, Lots 351, 352 and 370, as Set Out and Delineated on City Assessor's Plat 98; Said Lots being located along the Easterly Side of Charles Street and Designated as 663-669 Charles Street, bounded and described as follows:

Beginning at the southeasterly intersection of Charles Street and Paul Street, thence easterly along the southerly line of Paul Street to the northwesterly corner of Lot 353, thence southerly bounded easterly by Lots 353 and 369 to the southeasterly corner of land, herein described, thence westerly bounded southerly by Lot 371 to the easterly line of Charles Street, thence northerly along the easterly line of Charles Street to the southeasterly intersection of Charles Street and Paul Street, said point and place of beginning.

Section 2. This Ordinance shall take effect upon its passage.

FROM C-1 TO C-4

Gentlemen:

This petition from the Committee on Ordinances is a request to rezone Lots 351, 352 and 370 on Assessor's Plat 98 at 663-669 Charles St., from C-1 to C-4.

Lots 352 and 370 are presently in use by a wholesale heating equipment business which was relocated at this site in 1968 after being moved from its previous location by the Providence Redevelopment Agency as part of the East Side Renewal Project. Lot 351 is occupied by a $3\frac{1}{2}$ story frame building with a commercial use on the ground floor. The residential property at the rear of the subject lots is some 25' above the Charles St. grade. The surrounding area is mixed commercial and residential in use and is in fair condition.

No objection is offered by this department to the rezoning of this property from C-1 to C-4.

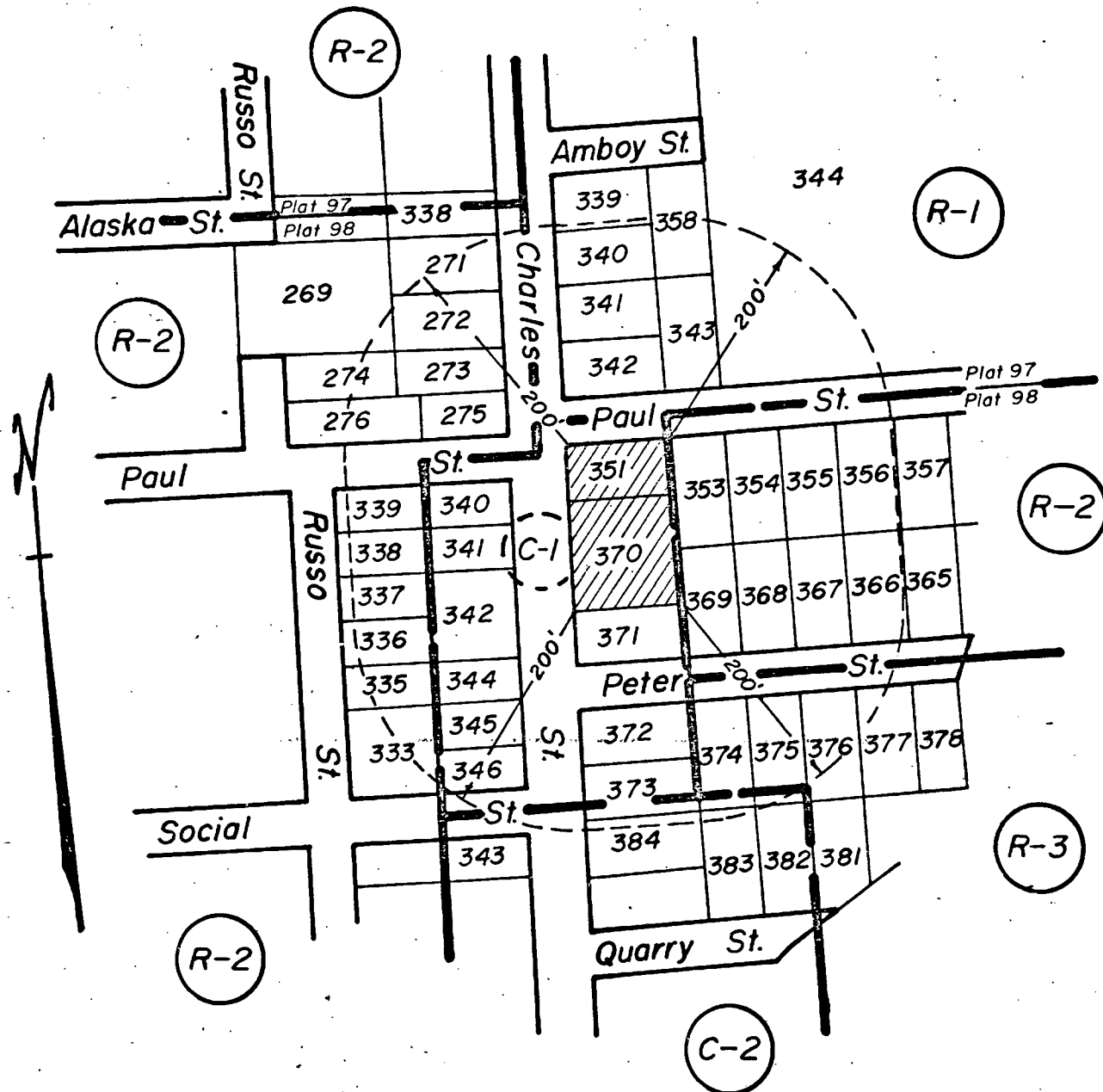
