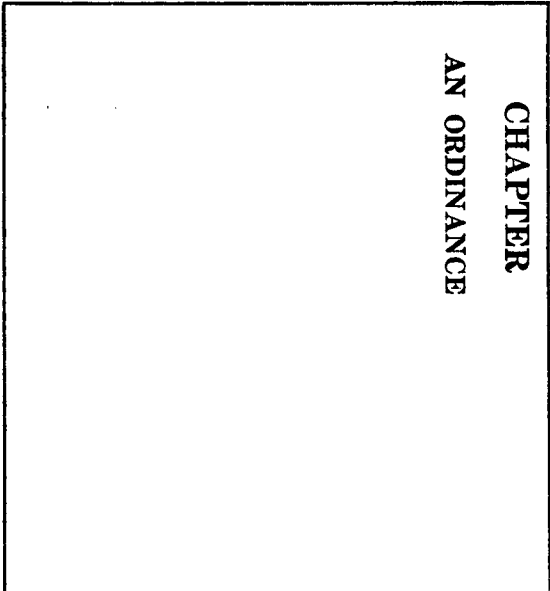

The Zoning Map accompanying and made a part of Chapter 544 approved September 21, 1951, entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height, and Area Regulations" is hereby amended by changing from a Residential R-2 Zone to a Commercial C-1 Zone Lots 394 and 250 as set out and delineated on City Assessor's Plat 107, said lots being located at the corner of Hartford Avenue and Heath Street, bounded and described as follows:

Beginning at the southwesterly corner of Hartford Avenue and Heath Street; thence southerly along the westerly line of said Heath Street to the southeasterly corner of Lot 250 on Assessor's Plat 107; thence westerly along the northerly line of Lot 395 to the southwesterly corner of Lot 394; thence northerly along the easterly line of Lot 401 to the southerly line of Hartford Avenue and the northwesterly corner of Lot 394; thence easterly along the said southerly line of Hartford Avenue to the southwesterly corner of Hartford Avenue and Heath Street and the point and place of beginning.

SUBJECT: REFERRAL NO. 527 - ZONING CHANGE ON THE CORNER OF HARTFORD AVENUE AND HEATH STREET

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, September 22, 1953.

This referral is a request for a change in zoning from an R-2 Zone to a C-1 Zone of Lots 394, 250, 395, and 396 on Assessor's Plat 107, located at the corner of Hartford Avenue and Heath Street. The land in question contains a total of 16,100 square feet.

On the field trip it was found that the area in question is at present vacant, with the exception of a few pieces of construction equipment believed to be used in connection with the Hartford Park Housing Project.

A telephone conversation with Mr. Lyons of the Providence Housing Authority revealed that he was opposed to any use other than residential. Mr. Lyons made reference to a previous petition within the project area, for a C-1 change, and stated that he should be consistent in his recommendations.

There is ample area zoned for business throughout this general area even in view of the increased number of families attracted by the new housing project.

* In order to protect the character of the neighborhood as well as

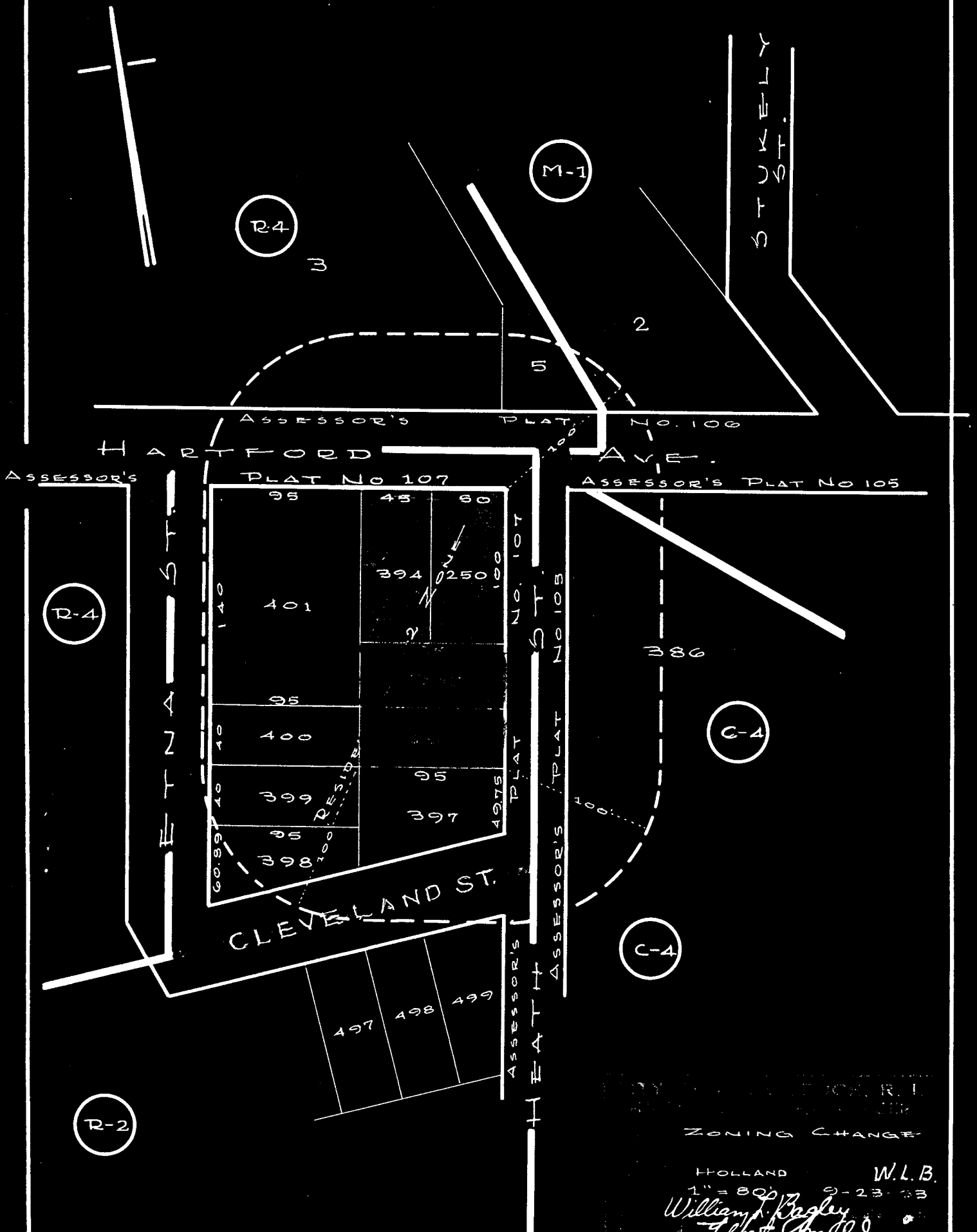


