Gentlemen:

The Foundation for Repertory Theatre of Rhode Island, Inc. (the "Foundation") is the owner of that certain parcel of realty and improvements thereon located at 201 Washington Street, in the City of Providence and designated as Lot No. 186 on Tax Assessor's Plat No. 25, together with contents, (the "Property").


The Property is exempt from the property taxes by reason of an Act of the Rhode Island General Assembly in 1979.

The Foundation hereby agrees that, commencing with the 1981 tax year, the Foundation will make payments in lieu of taxes on the Property in an amount equal to \$2,500 per year. Such payments in lieu of taxes will be treated as though they were taxes on the Property, and will be treated by the Foundation as having been assessed as of December 31, and payable in four installments commencing in the next succeeding July. Accordingly, the Foundation will make its first quarterly payment in July of 1981.
