## CHAPTER 1972-24

No. 181 **AN ORDINANCE** IN AMENDMENT OF SECTION 2-7 AND SECTION 2-8 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, RHODE ISLAND, APPROVED OCTOBER 21, 1968, AS AMENDED, PROVIDING FOR THE BESTOWAL OF THE MUNICIPAL MEDAL TO ANY DESERVING PERSON OR PERSONS WHO HAS PERFORMED AN EXTRAORDINARY ACT OF BRAVERY OR VALOR WITHIN THE CITY OF PROVIDENCE.

### Be it ordained by the City of Providence:

SECTION 1. Section 2-7 entitled, "Person Upon Whom Municipal Medal Bestowed", is hereby amended to read as follows; "The City Council by Resolution may bestow the Municipal Medal upon any Policeman, Fireman or other Officer or Employee of the City, in the line of his duty as such officer or employee, or any deserving person or persons who shall hereafter perform an extraordinary act of bravery or valor".

SECTION 2. Section 2-8 entitled, "Acts of Bravery or Valor Warranting Receipt of Medal", is hereby amended to read as follows; "Whenever it shall be suggested by the Mayor or a Member of the City Council that a Policeman, Fireman or other Officer or Employee of the City, in the line of his duty as such officer or employee, or any deserving person or persons has performed an extraordinary act of bravery or valor, the matter shall be referred to the Committee on Public Welfare of the City Council for investigation. Said Committee shall hear and receive evidence concerning the act referred to it and shall report to the City Council its findings upon the facts, together with its recommendations, as to whether the act, referred to it for investigation, is of such extraordinary bravery or valor, in the line of duty, as to entitle such Policeman, Fireman or other Officer or Employee of the City, or any deserving person or persons, to receive the municipal medal".

SECTION 3. This Ordinance shall take effect upon its passage.
