RESOLUTION OF THE CITY COUNCIL

No. 19

Approved January 24, 2001

WHEREAS, the City of Providence is committed to working with the Providence Redevelopment Agency (PRA) in implementing the Promenade Center Renewal Project;

WHEREAS, the City Council has approved the Promenade Center Renewal Project plan on March 23, 1984, with an amendment approved on April 17, 1989;

WHEREAS, the City Council authorized the taking by condemnation of AP 26, Lots 255, 319 and 344 on March 23, 1989;

WHEREAS, the PRA condemned the aforesaid lots to create Parcel 1 in the Promenade Center Renewal Project;

WHEREAS, a certain parcel land, AP 26, Lot 258, measuring 2,506 square feet, is currently owned by the City of Providence;

WHEREAS, AP 26, Lot 258 abuts Parcel 1 and is needed for the redevelopment of Parcel 1;

NOW, THEREFORE, BE IT RESOLVED, That deeds be executed to transfer AP 26, Lot 258 to the Providence Redevelopment Agency and that the Providence Redevelopment Agency shall see that said property is developed in accordance with the Promenade Center Renewal Project Plan, *Providence 2000: The Comprehensive Plan* and City of Providence Zoning Ordinance;

BE IT FURTHER RESOLVED, That His Honor, the Mayor is hereby authorized to execute any and all documents, including deeds, relative to the conveyance of said parcels.

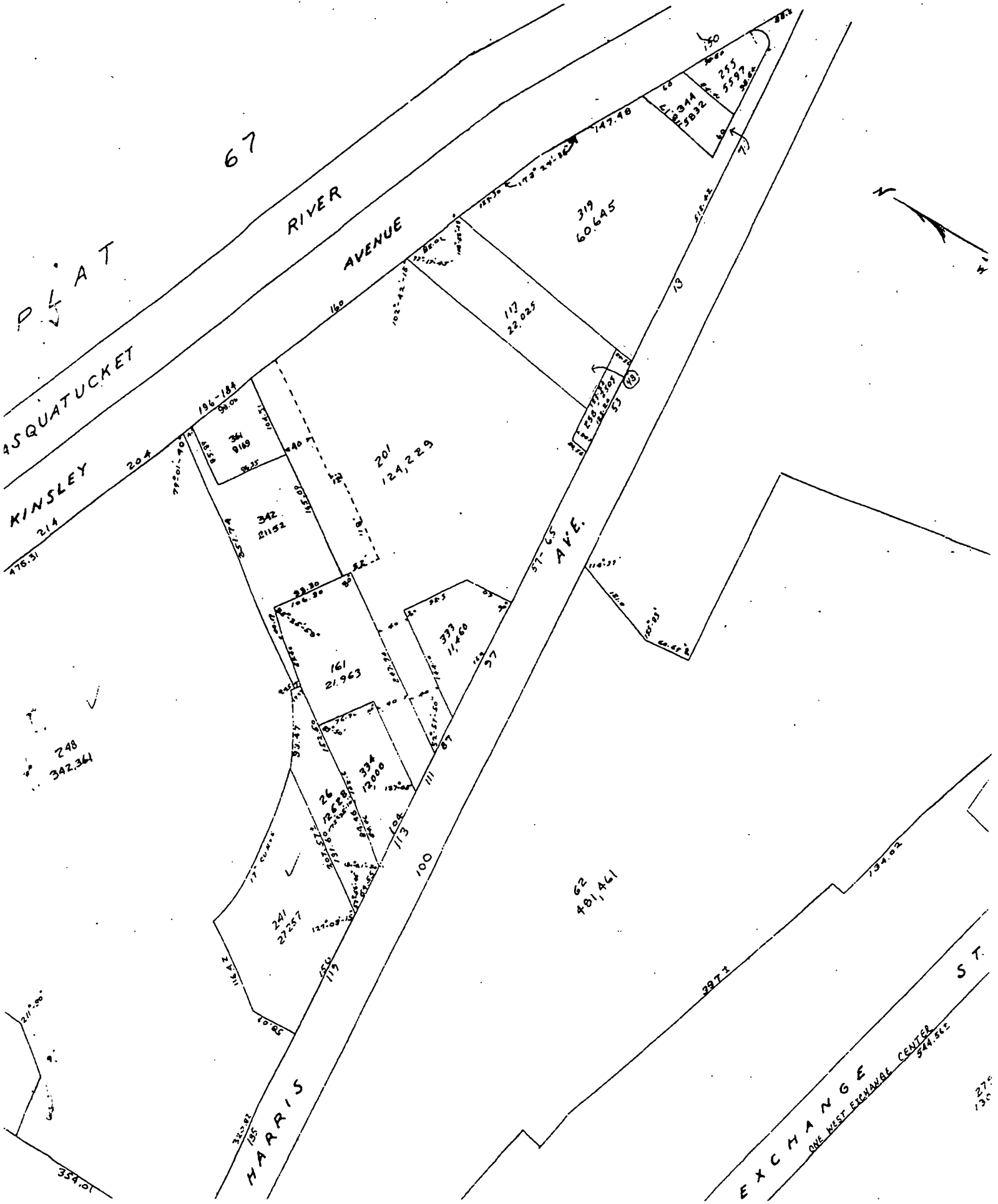
