## CHAPTER 1978-4

No. 25 **AN ORDINANCE** GRANTING THE CONSENT OF THE CITY OF PROVIDENCE TO THE ACQUISITION OF ITS PROPERTY, ESTATE AND INTEREST IN CERTAIN REAL PROPERTY IN THE DOWNTOWN PROVIDENCE RENEWAL PROJECT BY THE PROVIDENCE REDEVELOPMENT AGENCY.

Approved January 30, 1978

*Be it ordained by the City of Providence:*

SECTION 1. Pursuant to the provisions of Title 45, Chapter 32, Section 25 of the General Laws of Rhode Island, 1956 (as amended) the City of Providence hereby consents to the acquisition by the Providence Redevelopment Agency by eminent domain proceedings, or by purchase, of the fee to, and all of the estate and interest of the City of Providence in and to the following described lots or parcels of land together with all buildings or improvements thereon and all air space and air easements in connection therewith, to wit: ASSESSORS PLAT 19 (Nineteen), LOTS 31 (Thirty one) and 32 (Thirty two) being generally described as the parking deck in front of Union Station and the east and west approaches thereto.

SECTION 2. The said acquisition is in conjunction with the Downtown Providence Renewal Project approved by the Providence City Council on February 14, 1977 by Chapter 1977 - 5 No. 64 AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR DOWNTOWN PROVIDENCE RENEWAL.

SECTION 3. This Ordinance shall take effect upon its passage.
