



BOARD OF PARK COMMISSIONERS

MEETING OF TUESDAY, OCTOBER 4, 1988

M I N U T E S

MEMBERS PRESENT: Chairman Paolino, Commissioner Bucci, Commissioner Cullinan, Commissioner DeSimone, Commissioner Fagnoli, Commissioner Smith and Commissioner Weingeroff

OTHERS PRESENT: Nancy Derrig, Superintendent of Parks, Robert McMahon, Deputy Superintendent, John Campanini, Chief Parks Planner

I. CALL TO ORDER

In the temporary absence of the Chairman, Vice Chairman DeSimone, declaring a quorum present, called this meeting to order at 8:50 a.m.

II. APPROVAL OF MINUTES - MEETING OF JUNE 7, 1988

Commissioner Cullinan requested the June Minutes be amended to read "Miss Margaret McCarthy" instead of "Mrs. Margaret McCarthy" under Item VIII. Commissioner Smith moved to accept the Minutes as amended. Motion seconded by Commissioner Fagnoli. Motion carried.

III. ELECTION OF VICE CHAIRMAN

Vice Chairman DeSimone moved to nominate Commissioner Smith as a Co-Vice Chairman. Motion seconded by Commissioners Fagnoli and Weingeroff. Motion carried.

(VII. Proposed Park Land Disposition, Continued)

. Collyer Park

On a motion by Commissioner Fagnoli and seconded by Commissioner Smith, a motion carried to sell approximately 1.5 acres of unused land in Collyer Park to the Providence Redevelopment Agency for use in commercial development. The Commission directed the Parks staff to develop conditions of sale to ensure that neighborhood residents are not adversely affected by re-use of the 1.5 acres for commercial development.

. Baxter Park, Peach Street Park, Rhodes Street Park, Burnett Street Park, Diamond Street Park, and Niagara Street Park

On a motion by Commissioner Fagnoli and seconded by Commissioner DeSimone, a motion carried to seek transfer of the above tax-reverted lands to the Providence Redevelopment Agency for disposition to the public in the Vacant Lot Program.

. Salisbury Street Park, Waldo Street Park and Oakland Street Lot

On a motion by Commissioner Fagnoli and seconded by Commissioner DeSimone, a motion carried to seek transfer of the above land to the Providence Redevelopment Agency for disposition to the public.



. Laurel Hill Park and Richardson Park

On a motion by Commissioner Fagnoli and seconded by Commissioner DeSimone, a motion carried to seek transfer of the above land to the Providence Housing Authority.

VIII. NEW BUSINESS

Vice Chairman DeSimone indicated that the Perennial Planters, a Providence Garden Club, which is renovating vacant land on Benefit Street as a park, intends to submit a request to the Department of Public Parks for \$5,000 to complete the work.

Vice Chairman DeSimone alerted Superintendent Derrig to the fact that a resident on Wheaton Street, Professor Morse from Brown University, was placing construction rubble on park-owned land on lower-Prospect Terrace. Superintendent Derrig indicated that she would contact the Building Inspector.

In the Summer of 1988, the Department of Public Parks began construction work to renovate the Laurel Hill Playground which was then under the jurisdiction of the Parks Department.

As construction work was proceeding on the project, inquiries were made by the Providence Housing Authority as to the availability of this parcel of land for use as proposed housing for the homeless.

The Board of Park Commissioners, at their meeting of October 4, 1988, voted to transfer ownership of the Laurel Hill Playground to the Providence Housing Authority for this specific use. Also included in this transfer was the understanding that the tot-lot area be left accessible for use by the neighborhood children.

Please accept our apologies for not informing the City Properties Committee of this transfer to another city agency. It was our understanding that only City of Providence property being sold or leased need the approval of your committee.
