RESOLUTION NO. 71 Project No. _____
(For HHFA use.)

Resolution providing for increase in planned total expenditure for capital improvement projects.

Whereas, under the terms of Public Law 87-658, approved September 14, 1962, the United States of America has authorized the making of a grant to aid in financing the construction of a specific public works project, provided the proposed or planned total expenditure of the public body for its capital improvement projects is increased by an amount approximately equal to the non-Federal funds required to complete such public works project:

Now, Therefore, Be It Resolved By The City Council, City of Providence, Rhode Island
Governing Board of Applicant

1. That as of the date of filing of an application by City of Providence
(Exact Legal Corporate Name of Applicant)
(hereafter called Applicant) with the Housing and Home Finance Agency, United States Government, for a grant to aid in financing the construction of an Off-Street Parking Garage.
(Brief Project Description)
the Applicant had a capital improvements plan or capital improvement budget for the fiscal year or years during which construction of the proposed project is expected to occur; and that the total expenditure for capital improvements in said plan or budget was \$ 3,108,500 for the fiscal year ending 9/30/62 and \$ 4,010,000 for the fiscal year ending 9/30/64.
2. That, in the event that said Federal grant is approved by the United States of America, said capital improvements plan or capital budget will be is hereby increased by \$ 198,000 for the fiscal year ending 9/30/63 and \$ 297,000 for the fiscal year ending 9/30/64 for a total increase of \$ 495,000 in the proposed or planned total expenditure for capital improvement projects (exclusive of Federal funds).
3. That said total increase in the proposed or planned total expenditure for capital improvement projects is approximately equal to the non-Federal funds required to complete the public works project for which the application is to be submitted.

This resolution is adopted pursuant to the authority provided by Chapter 121 of the 1960 Public Laws of the State of Rhode Island. (cite applicable State or

local law).

4. Resolution No. 659 Approved December 21, 1962 is hereby rescinded.

WHEREAS, there is in the midst of us a gentleman who has rendered many years of devoted and immeasurable service to the City of Providence, and

WHEREAS, this amiable gentleman whose constituents, cognizant of his ability, integrity and zeal; have seen fit to re-elect him eleven consecutive times since his original election in 1940 attesting to their confidence in this tried and true public servant, and

WHEREAS, his colleagues in the City Council in 1959 elevated him to the highest position within their province - that of President of the City Council - an office he occupied with dignity and tact until he announced late in 1962 that he would not be a candidate to succeed himself, and

WHEREAS, on the several occasions when he was called upon as Acting Mayor to direct the affairs of the city, he was more than equal to the task. In the late summer of 1954, as President Pro Tempore, he marshalled the city's manpower and all of its facilities to erase the devastation caused by one of the worst hurricanes in history, and

WHEREAS, his outgoing and generous personality has had many facets: his compassion for the under dog; his untiring efforts on behalf of the Knights of Columbus and other beneficial organizations including the Ancient Order of Hibernians whose policies he championed for the freedom of Ireland and later opposed its partition. Locally, at his urging, Journal Square became Robert Emmett Square.

NOW, THEREFORE, BE IT RESOLVED, That His Honor Mayor Walter H. Reynolds, the members of this and previous city councils would hereby record their happy association with him and extend to him their sincere appreciation for the courteous, equitable and impartial treatment which he has accorded them. Gentlemen:

Title 45, Chapter 31, Section 19 of the General Laws of Rhode Island, 1956, as amended, requires any officer of a redevelopment agency who owns or has any financial interest, direct or indirect, in any property included within a redevelopment project area to disclose such interest to the legislative body of the community; and such disclosure shall be entered in the minutes of the legislative body.

International Supply Co., which was incorporated under the laws of the State of Rhode Island on March 14, 1941, is the owner of certain parcels of improved real estate situated at 90 South Water Street and 201-205 South Main Street, Providence, Rhode Island. These parcels of land are designated as lots 511, 26 and 25 on Plat No. 16 of the records of the Tax Assessor of this City. The property designated as lots 511 and 26 on the aforementioned plat was acquired by International Supply Co. on March 17, 1941. The other lot was acquired by the corporation on April 25, 1962. The corporation was authorized to issue 500 shares of no-par value common stock. Four hundred thirty shares have been issued. I am the owner of 178 of the shares which have been issued.

The aforementioned lots are located within the bounds of the East Side Renewal Project Area No. R. I. R-4. The first application for federal assistance in the planning of this project was approved by the Agency on January 14, 1960. Since that date, no final plans or policies have been formally adopted by the Agency relative to the portion of the South Main and South Water Street area which is within the project area. As of this date, no plans or policies have been made regarding the acquisition by the Agency of either of the aforescribed properties.
